- 16 COULD BE DONE WITH THE ASSISTANCE OF COLBY TECHNOLOGIES.

- 11 MR. CAYAYAB: NELSON CAYABYAB.
- 12 YES, YOU'VE ALREADY BEEN PROVIDED AN EXCEL
- 13 SPREADSHEET, AND WE'VE BEEN DISCUSSING THAT INFORMATION IS
- 14 THERE WITH THE EXCEPTION OF THE PROJECT COMPLETIONS AND
- 15 THINGS LIKE THAT. WE HAVE TO GET THAT TO YOU PERSONALLY,

- 4 SOME OF THIS INFORMATION IS IN THE ACCOUNTABILITY SYSTEM
- 5 AND SOME OF IT ISN'T IN ACCOUNTABILITY, BIG A. IN MY MIND
- 6 I KIND OF ORGANIZED IT MAYBE INTO TWO SEPARATE SETS OF
- 7 INFORMATION, AND ONE IS JUST THE COMPLETE FINANCIAL
- 8 PICTURE; THE OTHER WOULD BE CURRENT AND MAYBE EVEN FUTURE

- 12 CLARIFY THAT WHEN THE REPORT TITLE SAYS SOMETHING THAT IT'S
- 13 THE SAME MEANING THAT WE THINK WHEN WE'RE READING IT.
- 14 BECAUSE SOMETIMES IT WILL SAY THIS, AND IT'S REALLY
- 15 SOMETHING SLIGHTLY DIFFERENT. AND I JUST WANT US TO SAY
- 16 WHEN WE LOOK AT IT GO, THAT'S WHAT WE WANT. THAT'S WHAT WE
- 17 MEANT TO GET, AND THAT'S ACTUALLY WHAT IS THERE.
- 18 SO IF WE CAN BE A LITTLE BIT MORE PATIENT, AND
- 19 I'M HOPING THAT IF WE FIND SOMETHING THAT'S RELATIVELY EASY
- 20 TO SPIT OUT OF ACCOUNTABILITY, THAT IT MIGHT BE DONE SOONER
- 21 THAN AUGUST.
- NOW THE OTHER PART, THE STATUS TO ME IS ALSO
- 23 REALLY IMPORTANT, AND THAT'S THE ONE THAT'S PROBABLY GOING
- 24 TO BE A LITTLE BIT MORE MANUAL AT LEAST. I THINK THE
- 25 VERSION QUINCY HAD HAD KIND OF, YOU KNOW, WHAT'S THE LATEST

- 1 THAT'S GOING ON WITH THIS PROJECT. SO THAT MAY BE
- 2 SOMETHING THAT PROJECT MANAGERS OR SOMEONE FROM FACILITY
- 3 KIND OF COORDINATES, AND THAT WOULD BE THE ONE WITH THE
- 4 PERCENTAGE COMPLETE AND THE DATE. SOMETHING THAT TELLS YOU
- 5 ARE THESE PROJECTS ON TIME AND PROGRESSING, BUT SEPARATE
- 6 FROM THE FINANCIAL, AND HOPEFULLY THAT -- HOPEFULLY THE
- 7 PRACTICALITY OF IT BEING EASY AND MORE REGULAR MITIGATES
- 8 THE FACT THAT IT WON'T ALL BE ON ONE PAGE.
- 9 MR. HOCUTT: MIGHT BE THREE PAGES.
- 10 MS. KENNE: ALL IN ONE REPORT I SHOULD SAY.
- MR. HOCUTT: QUINCY.
- 12 CAN WE MEET VERY SOON? BECAUSE FRANKLY THIS
- 13 COMMITTEE MEETS ONCE A MONTH, AND THIS THING COULD GO UNTIL
- 14 OUITE A WHILE. SO CAN WE MEET?
- 15 MS. KENNE: YES. AND I'LL JUST SAY THAT AT MY AGE THE
- 16 MONTHS GO BY LIKE THAT (SNAPPING FINGERS). A MONTH DOESN'T
- 17 FEEL THAT LONG TO ME ANYMORE.
- 18 MR. HOCUTT: I'M OLDER THAN YOU ARE.
- 19 MR. CATES: AND WHILE THE MONEY GOES BY LIKE THAT
- 20 (SNAPPING FINGERS), THE MONEY GOES BY LIKE THAT WITHOUT OUR
- 21 ABILITY TO MONITOR IT ADEQUATELY.
- GLENN, YOU HAVE A COMMENT?
- MR. DEVEER: YES. GLENN DEVEER.
- 24 I HAVEN'T DELVED INTO THE OWNER-CONTRACTOR
- 25 AGREEMENTS AS OF YET. BY OWNER I MEAN PUSD OR FACILITIES

- 1 IN THIS CASE, I THINK. BUT NELSON TOLD ME SOME MONTHS AGO
- 2 THAT THEY USED AN AIA DOCUMENT OR SOME DERIVATIVE OF THE
- 3 AIA DOCUMENTS. AIA DOCUMENTS WHEN A CONTRACTOR MAKES A
- 4 CERTIFICATION AND APPLICATION FOR PAYMENT ON A MONTHLY
- 5 BASIS, HE CARRIES THERE THE COSTS OF THE PROJECT; HE
- 6 CARRIES THERE THE AMOUNT OF CHANGE ORDERS; THE QUANTITY OF
- 7 CHANGE ORDERS; HE CARRIES THERE THE TOTAL AMOUNT THAT'S
- 8 DUE, AND THEN HE CARRIES THERE THE PERCENTAGE OF
- 9 COMPLETION. WHAT YOU'RE LOOKING FOR, QUINCY.
- 10 MY QUESTION TO NELSON WOULD BE DOES THAT EXIST,
- 11 OR DO WE HAVE THAT TOOL IN OUR TOOLBOX?
- MR. CAYABYAB: NELSON CAYABYAB.
- 13 THAT IS CORRECT. NOT ONLY THAT, BUT THEY GO
- 14 THROUGH THE SCHEDULE OF VALUES AS ATTACHED TO EVERY PAYMENT
- 15 APPLICATION, AND THAT'S WHEN THE PM'S, THE DISTRICT REVIEW
- 16 IT SO THAT IT'S LEGITIMATE THAT MUCH WORK WAS DONE AND
- 17 COMPLETED PER ITEM IN THE SCHEDULE. AND THAT IS -- I THINK
- 18 STAFF SENT YOU A SAMPLE OF A PURCHASE ORDER, THE
- 19 TRANSMITTAL SHEETS, THE SCHEDULE OF VALUES AS WELL AS THE
- 20 PROJECT INSPECTORS DAILIES ATTACHED TO THAT. SO THAT IS
- 21 AVAILABLE IN OUR TOOLBOX, AND WE CAN CERTAINLY PROVIDE THAT
- 22 TO YOU AS MUCH AS YOU WANT. I GO THROUGH THESE THINGS
- 23 REGULARLY ON A DAILY BASIS SO THAT CERTAINLY IS AVAILABLE.
- MR. CATES: YOU KNOW, I DON'T WANT US TO GET HUNG UP
- ON PROCESS. WHAT SOFTWARE WILL DO IT? WHICH STAFF MEMBER

- 1 WILL DO IT? WE'VE BEEN TALKING ABOUT THIS FOR AT LEAST
- 2 THREE MONTHS, AND WE COULD HAVE CREATED THE NECESSARY
- 3 REPORTS -- OR THE REPORTS THAT THE COMMITTEE WANTS MANUALLY
- 4 LONG AGO. SO IT IS MY OPINION THAT UNLESS WE CAN COME UP
- 5 WITH AN AGREED FORMAT THAT IS ACCEPTABLE TO THE DISTRICT
- 6 THAT WE SIMPLY SOLICIT THE INFORMATION AND START DOING IT
- 7 OURSELVES UNTIL SUCH TIME AS THE SYSTEM WILL SPIT IT OUT.
- 8 MS. VANCE: GRETCHEN.
- 9 I THINK THAT WHAT KIM IS TRYING TO SAY IS THAT
- 10 THERE IS REPORTS THAT ARE NUMBERS THAT CAN BE GENERATED
- 11 FROM THE SYSTEM. BOOM. THEY CAN GENERATE THE REPORT. BUT
- 12 THE STATUS STUFF IS VERY MANUAL. THE STATUSES IS YOU CAN'T
- 13 PULL FROM COLBY. YOU CAN'T PULL THE STATUSES FROM
- 14 ACCOUNTABILITY SOFTWARE.
- 15 SO I THINK WHAT KIM IS TRYING TO SAY IS IF WE CAN
- 16 COME TO THE CONCLUSION AS A COMMITTEE THAT TWO SEPARATE
- 17 REPORTS WILL BE ACCEPTABLE, MEANING ONE THAT'S FINANCIAL
- 18 THAT GETS PULLED OUT OF THE -- IT'S JUST A BUTTON YOU
- 19 PRESS, AND SAY WE PUT ALL THE INFORMATION, WE'RE
- 20 WITHDRAWING ALL THE INFORMATION OUT IN THE WAY THAT WE
- 21 WANTED AND THEN A SEPARATE REPORT THAT HAS A STATUSES OF
- 22 THE PROJECTS, WOULD THAT BE ACCEPTABLE TO THE COMMITTEE,
- 23 AND, IF SO, OF THESE TEN ITEMS ON YOUR LIST FROM YOUR
- 24 LETTER, WHICH ONES WOULD FALL UNDER THE FINANCIAL AND WHICH
- 25 ONES WOULD FALL UNDER THE STATUS. THAT'S HOW I ORGANIZE

- 1 EVERYTHING IN MY HEAD. FOR ME I WOULD BE FINE WITH THAT.
- 2 I DO KNOW THAT THERE IS INFORMATION ON THIS LIST THAT IS
- 3 IMPOSSIBLE TO BE GENERATED FROM A COMPUTER. IT'S A
- 4 DATABASE. IT'S A SYSTEM.
- 5 MR. CATES: I GRANT THAT. BUT WHY DO WE HAVE TO LIMIT
- 6 OUR REPORT TO WHAT A DATABASE SPITS OUT? THE WHOLE POINT
- 7 OF THIS IS TO HAVE ONE REPORT, ONE SHEET -- ACTUALLY, IT
- 8 WILL BE SEVERAL BECAUSE THERE ARE A NUMBER OF PROJECTS --
- 9 BUT ONE SHEET THAT ANYONE ON THE BOARD OR THIS COMMITTEE OR
- 10 ANYONE FROM THE PUBLIC CAN LOOK AT AND SEE BLAIR MIDDLE
- 11 SCHOOL, ORIGINAL BUDGET, REVISED BUDGET, AMOUNT SPENT TO
- 12 DATE. I THINK IT ALSO OUGHT TO INCLUDE COMMITMENTS,

- MS. RAHN: WE CAN ALL AGREE ON THAT, BUT I DON'T THINK
- 16 THAT'S THE KIND OF THE INFORMATION WE WOULD BE LOOKING AT
- 17 TO BE HONEST.
- 18 MR. CATES: KIM, YOU'RE OUR BOARD LIAISON. WHERE DOES
- 19 THIS MATTER STAND WITH THE BOARD?
- 20 MS. KENNE: MY UNDERSTANDING IS THAT FACILITIES WILL
- 21 BE LOOKING AT THE SPEND-OUT PLAN IN THE FORM KIND OF AS A
- 22 PRIORITIZATION LIST BECAUSE THERE ARE THE MULTICOLORED
- 23 DOCUMENTS, OR AS I CALL IT THE BLUE AND GREEN, BUT IT ALSO
- 24 HAS ALSO YELLOW THAT I THINK WE ARE CALLING THE SPEND-OUT
- 25 PLAN THAT ADDS UP TO THE 126. THERE'S ACTUALLY A

- 4 BUT I THINK -- I DON'T KNOW THAT I'M SPEAKING FOR
- 5 THE ENTIRE BOARD, BUT I'M SPEAKING FOR MYSELF BECAUSE WE
- 6 LAST FORMALLY, YOU KNOW, AGREED WITH THE PUBLIC
- 7 THIS-IS-HOW-WE'RE-SPENDING-YOUR-MONEY BACK IN 2012. ANY
- 8 DECISIONS THAT WE'VE MADE, GREAT. BUT IT FEELS LIKE WE'RE

- 3 MR. VANCE: GRETCHEN.
- 4 I WANT TO MAKE THE COMMENT THAT ONE OF THE THINGS
- 5 THAT I DID AS CHAIR LAST YEAR WHEN I PRESENTED MY REPORT TO
- 6 THE SCHOOL BOARD, I SAID ONE OF MY MAIN CONCERNS IS THAT --
- 7 MY MAIN CONCERN -- I EVEN WROTE IT IN THE REPORT -- IS THAT
- 8 YOU AS A SCHOOL BOARD HAVE PROMISED THE VOTERS THAT YOU
- 9 WOULD UPDATE THE MASTER PLAN EVERY YEAR. YOU HAVE FAILED
- 10 IN THAT PROMISE TO THE PUBLIC AND TO THE VOTERS.

- 6 MS. KENNE: THIS IS KIM.
- 7 I DESCRIBED MY IDEAL WORLD AND, YOU KNOW, TIME
- 8 GETS IN THE WAY, AND I KNOW WE DON'T WANT TO HOLD THINGS
- 9 UP. SO THERE ARE WHAT I LAID OUT FOR YOU AND WHERE WE END
- 10 UP MAY BE SLIGHTLY DIFFERENT. BUT, I MEAN, THAT'S WHAT I'M
- 11 HOPING TO BE ABLE TO GIVE EVEN IF IT'S IN SOME KIND OF
- 12 DOCUMENT THAT JUST SHOWS THE RELATIONSHIP OF THE PRESENT TO
- 13 THE PAST AND PLUSES AND MINUSES, YOU KNOW. WHETHER THERE'S

- 25 CONSTRUCTION, AND THEN THERE'S A NEXT SET THAT I BELIEVE

- 1 HAS ALREADY BEEN BID, PUT OUT TO BID.
- 2 MR. CAYABYAB: NELSON.
- WE'RE IN THE PROCESS.
- 4 MS. KENNE: SO THERE ARE CERTAIN PIECES OF IT GOING
- 5 FORWARD NO MATTER WHAT. WE COULDN'T SAY, OOPS, NO, WE
- 6 DON'T WANT TO DO THAT ANYMORE. IT'S TOO FAR ALONG. NOW, I
- 7 THINK WE MAY HAVE SOME TIME, WE HAVE A WINDOW OF TIME TO
- 8 TRY AND FIGURE OUT THE REST. BUT THE PRIORITIZATION LIST I
- 9 THINK THE FIRST -- UP TO NO. 9, ALTHOUGH THERE ARE SOME
- 10 SUB-PIECES ON THAT LIST, SO IT'S A LITTLE BIT MORE THAN
- 11 EIGHT ARE UNDERWAY. SO THEY'RE AT THE TOP. THEY'RE
- 12 ALREADY TOO FAR ALONG TO STOP.
- 13 MR. CATES: KIM, WILL THE SPEND-OUT PLAN AFFECT A NEW
- 14 FACILITIES MASTER PLAN?
- 15 NELSON?
- MR. CAYABYAB: NELSON CAYABYAB.
- 17 LET ME CLARIFY A LOT OF THINGS THAT ARE COMING
- 18 UP. THE SPEND-OUT PLAN WAS INFORMATION THAT STAFF WANTED
- 19 TO PROVIDE YOU TO BE TRANSPARENT. WHAT IT IS ON THE LAST
- 20 COLUMN BECAUSE OF THE INCREASE OF CONSTRUCTION COSTS,
- 21 BECAUSE OF ALL OF THE THINGS, THE BID BEHAVIOR, THE BID
- 22 CLIMATE NOW IS A LOT MORE THAN WHAT WE SUSPECTED. SO
- 23 THAT'S WHEN THE BUDGET THAT WE FORESAW AT THE TIME THREE OR
- 24 FOUR YEARS AGO DOESN'T MEET IT. SO STAFF IS PROJECTING
- 25 THAT BECAUSE OF THE BID CLIMATE, WE SUSPECT THAT NORMA

- 1 COOMBS WILL GO FROM 4 POINT TO 6 POINT SOMETHING. ERGO,
- 2 WHAT HAPPENED TO THE PHS THAT WE SENT RECENTLY THE BID?
- 3 SAME THING WITH THE JOHN MUIR PROJECTS THAT WE RECENTLY
- 4 BID. WE ARE LOOKING AT 25 PERCENT INCREASE OF WHAT WE
- 5 BUDGETED FOR. SO THAT'S WHAT STAFF IS PROJECTING ON THAT
- 6 SPEND-OUT PLAN THAT YOU FOLKS ARE SO CONCERNED ABOUT.
- 7 NOW, AS FAR AS WHERE THAT MONEY IS GOING TO COME
- 8 FROM, WE'VE ALREADY PROVIDED 1 THROUGH 27 LIST OF
- 9 PRIORITIES. THE FIRST 8 OR 9 WE DON'T HAVE A CHOICE. WE
- 10 HAVE SPENT SO MUCH MONEY ALREADY IN THAT WITH THE PLANS,
- 11 UNDER THE SA, UNDER CONTRACT AND SO FORTH. THEN FROM 9 ON
- 12 THE LIST OF IT I'VE ASKED THE BOARD TO REPRIORITIZE SOME OF
- 13 THESE THINGS WHICH A LOT OF THEM REPLIED BACK STAY WITH
- 14 THAT PRIORITIZATION LIST.
- 15 SO THE PLAN NOW NORMA COOMBS IS GOING TO BE THE
- 16 FIRST ONE TO GO OUT TO BID. SO IF NORMA COOMBS COMES UNDER
- 17 6.9, GREAT. WE'VE GOT THE MONEY BUDGETED FOR IT. IF NORMA
- 18 COOMBS COMES AT \$10 MILLION, WHAT'S GOING TO HAPPEN TO THE
- 19 ADDITIONAL 3 MILLION IS GOING TO COME FROM THE BOTTOM OF
- 20 THE PRIORITY LIST TO GET THAT PROJECT AT NORMA COOMBS DONE,
- 21 AND I WILL PROVIDE THE TRANSPARENCY TO THE BOARD. THIS IS
- 22 THE RESULT OF THE BID FOR NORMA COOMBS. THIS IS WHAT WE'RE
- 23 PROJECTING, THE LOWER 26, 27 PROJECTS WILL BE THE ONE THAT
- 24 SUPPLEMENT THAT OR NOT DO THE PROJECT AT ALL.
- NOW, IF THE BOARD DECIDES NOT TO DO THE PROJECT

- 1 FOR NORMA COOMBS, ALL THAT WILL GO BACK AT THE BOTTOM OF
- 2 THE LIST, AND THE PRIORITY LIST GOES UP AGAIN. THAT'S HOW
- 3 WE'RE GOING TO DO THE PROCESS BECAUSE WE DON'T HAVE THE
- 4 FUNDING TO BE ABLE TO AFFORD WHAT WAS IDENTIFIED BACK IN
- 5 2012 IN THE MASTER PLAN UP TO NOW.
- 6 THERE'S ANOTHER SCENARIO IS THAT IF THERE ARE
- 7 OTHER AGENCIES THAT ARE WILLING TO DONATE THE MONEY FOR
- 8 CONSTRUCTION. A PERFECT EXAMPLE IS THE TRACK OVER AT
- 9 BLAIR. THERE'S A LOT OF -- THERE'S PEF, THERE'S A LOT OF
- 10 GROUP SOCCER THAT ARE COMING, DONATING THAT. IF THAT
- 11 HAPPENS, I WOULD BE FOOLISH TO SAY NO BECAUSE THAT'S ON THE
- 12 BOTTOM OF THE PRIORITY LIST, BUT WHAT I WILL DO THEN IS
- 13 BRING IT UP TO THE BOARD. LOOK, WE'VE GOT ADDITIONAL
- 14 FUNDING HERE. I RECOMMEND RECONSIDERING THIS PROJECT TO GO
- 15 HIGHER ON THE PRIORITY LIST, AND THIS IS HOW MUCH WE'RE
- 16 GOING TO GET OUT THE MASTER TT THE COST OF NO. 26 OR 27,
- 17 AND THE FUNDING FROM PEF AND THIS AND THIS SO WE CAN DO THE
- 18 PROJECT FOR BLAIR TRACK. SO THAT'S THE PROCESS OF WHAT
- 19 WE'RE TRYING TO DO.
- SO, IN ESSENCE, THE REMAINING OF THE FACILITY
- 21 MASTER PLAN FOR MEASURE TT IS REALLY PREDICATED ON THAT
- 22 LIST OF PRIORITIES THAT THE BOARD IS GOING TO APPROVE.
- 23 THAT'S HOW WE'RE GOING TO HANDLE THINGS TO SPEND THE
- 24 REMAINING OF THE \$124 MILLION NOW FOR THE MEASURE TT.
- MR. CATES: THANK YOU. I HOPE YOU DON'T THINK

- 1 WE'RE TAKING EXCEPTION TO ANY PARTICULAR NUMBER ON THE
- 2 SPEND-OUT PLAN. IT'S JUST THAT THE COMPARISON OF THOSE
- 3 NUMBERS TO THE EXISTING BUDGETED NUMBERS IS VASTLY
- 4 DIFFERENT. THAT'S ALL.
- 5 MR. CAYABYAB: NELSON CAYABYAB.
- 6 BECAUSE IT'S PROJECTED COST BY STAFF.
- 7 MR. CATES: I UNDERSTAND, AND I'M SURE THE BOARD IS
- 8 AWARE OF THE PROPOSED CHANGES AND THAT THEY ARE
- 9 SIGNIFICANT.
- 10 MS. VANCE: THIS IS GRETCHEN.
- 11 I JUST THINK THAT THEY'RE BREAKING THEIR PROMISE
- 12 TO THE VOTERS. I THINK THEY'RE BREAKING THEIR PROMISE TO
- 13 THE VOTERS AND TO THE PARENTS WHO WHEN THEY APPROVED A
- 14 MASTER PLAN AND NOW YOU'RE COMING UP WITH A WHOLE DIFFERENT
- 15 LIST OF THINGS AND SAYING WE'RE JUST GOING TO KEEP GOING
- 16 WITH THE LIST THAT WE THINK WE SHOULD DO INSTEAD OF JUST
- 17 SAYING HERE'S OUR NEW PLAN AND THIS IS WHAT WE'RE GOING TO
- 18 DO. UNLESS YOU WANT TO CALL THIS YOUR NEW PLAN, BUT YOU
- 19 CAN'T REALLY CALL THIS YOUR NEW PLAN BECAUSE YOU GUYS
- 20 DIDN'T VOTE ON IT. SO I HAVE A HARD TIME SAYING WE'RE JUST
- 21 GOING TO GO OFF OUR NEW LIST OF PRIORITIES. WHEN WE GO
- 22 BACK TO OUR SCHOOL SITE COUNCILS AND GO, HEY, BY THE WAY,
- 23 PHS YOUR POOL IS NO. 19 NOW, AND THEY GO WHAT THE HELL? IN
- 24 2012 THEY SAID THE POOL WAS GOING TO HAPPEN, AND NOW WE'RE
- 25 19, AND IT MAY NOT EVER HAPPEN BECAUSE 1 THROUGH 15, JUST

- 1 LIKE WHAT NELSON SAID, MAY GO OVER BUDGET, AND YOU'RE GOING
- 2 TO START FROM THE BOTTOM AND MOVE UP.
- 3 WHAT I'M SAYING IS THAT THE BOARD NEEDS TO MAKE A
- 4 DECISION, VOTE ON A NEW MASTER PLAN AND MOVE FORWARD. IT
- 5 REALLY DOESN'T HAVE ANYTHING DO WITH THIS COMMITTEE
- 6 HONESTLY BECAUSE EXCEPT FOR THE FACT THAT I FEEL LIKE PART
- 7 OF OUR ROLE IS TO MAKE YOU FOLLOW YOUR PROMISES YOU SET IN
- 8 HERE, BUT OTHER THAN THAT WE CAN'T TELL WHAT YOU TO DO. I
- 9 JUST DON'T THINK IT'S FAIR, AND I DON'T THINK THAT YOU'RE
- 10 GOING TO HAVE A CHANCE IN HECK OF PASSING ANOTHER BOND IF
- 11 YOU DON'T FOLLOW THE PROMISES IN THIS ONE, AND THAT'S MY
- 12 CONCERN AS A PARENT AND AS A CO-CHAIR OF THE PHS SCHOOL
- 13 SITE COUNCIL, AND I FEEL LIKE, YOU KNOW, THAT'S FINE. IF
- 14 YOU WANT TO MAKE A LIST, MAKE A NEW LIST.
- 15 MR. CATES: THE STENOGRAPHER DOES NOT KNOW WHAT THE
- 16 PROMISES ARE. WHY DON'T YOU READ THEM.
- 17 MS. VANCE: THE PROMISES UNDER MEASURE TT TRANSPARENCY
- 18 AND ACCOUNTABILITY, AND ONE OF THE BULLET POINTS UNDER THAT
- 19 SAYS, "LONG TERM FACILITIES MASTER PLAN UPDATED QUARTER AND
- 20 ANNUALLY." THE LAST TIME IT WAS UPDATED WAS IN 2012 AND
- 21 VOTED BY THE BOARD.
- 22 SO THAT'S JUST MY OWN FRUSTRATION WITH YOU
- 23 KNOW -- I GUESS LIKE -- I'M OKAY IF THE BOARD WANTS TO
- 24 DECIDE THAT THIS SPEND-OUT IS THE NEW MASTER PLAN, FINE.
- 25 THEN VOTE ON IT AND TELL EVERYBODY IT'S THE NEW MASTER

- 1 PLAN.
- 2 MS. KENNE: THIS IS KIM.
- 3 SO THE REASON I KIND OF STUMBLED AND HESITATED
- 4 WHEN YOU ASKED ABOUT THE FACILITIES MASTER PLAN BECAUSE THE
- 5 FACILITIES MASTER PLAN IS A BIGGER DOCUMENT, AND EVERY FIVE
- 6 YEARS, AND OUR OWN BOARD POLICY SAYS THAT WE SHOULD BE
- 7 REDOING OUR FACILITIES MASTER PLAN EVERY FIVE YEARS AND
- 8 LOOKING AT WHAT HAS CHANGED. WHAT'S CHANGING IN OUR
- 9 DEMOGRAPHICS? WHAT'S CHANGING IN THE PROGRAMS WE WANT FOR
- 10 THE FUTURE? HAS EVERYONE MOVED FROM THIS PART OF TOWN TO
- 11 THAT PART OF TOWN? HOW OUR FACILITIES NEED CHANGE. SO THE
- 12 FACILITIES MASTER PLAN ISN'T JUST HOW DO WE SPEND BOND
- 13 MONEY. IT'S ALSO WHERE ARE WE? WHERE DO THINK WE WE'RE
- 14 GOING TO BE? AND PROJECTING THAT IN THE PROJECT AND WHAT
- 15 ARE OUR NEEDS.
- 16 THAT KIND OF MARRYING THE NEEDS, NOT JUST OF THE
- 17 FACILITY NEEDS BUT THE PROGRAM NEEDS, AND WHAT WE'RE DOING
- 18 IS JUST A LITTLE MORE -- IT'S A LITTLE MORE ROBUST THAN
- 19 JUST UPDATING KIND OF THE SPENDING PLAN. SO WHAT WE'RE
- 20 SAYING IS WE THOUGHT WE WERE GOING TO SPEND ALL OF THIS.
- 21 BACK IN 2012 WE PUT A LIST OF THINGS ON A PIECE OF PAPER
- 22 AND MONEY ASSOCIATED WITH IT AND NOW COSTS HAVE GONE UP.
- 23 MAYBE SOMETHING THAT WAS EXTREMELY IMPORTANT IN 2012 ISN'T
- 24 ANYMORE, AND SO WE ARE JUST CHANGING UP THE SPENDING PLAN
- 25 WHICH ISN'T NECESSARILY THE WHOLE BIG FACILITIES MASTER

- 1 PLAN. THAT'S WHY I HESITATED IF YOU ASKED IF IT WAS. IT
- 2 IS A PLAN TOWARDS SPENDING ON FACILITIES, BUT IT'S NOT THE
- 3 FACILITIES MASTER PLAN.
- 4 MR. HOCUTT: THIS IS QUINCY.
- 5 I'D LIKE TO FOLLOW GRETCHEN HERE FOR JUST A
- 6 SECOND.
- 7 MS. VANCE: GREAT.
- 8 MR. HOCUTT: IT'S AN INTERESTING DISCUSSION, AND I
- 9 WILL FREELY ADMIT THAT THE BOARD HAS THE RIGHT TO WORK ON
- 10 ANY PROJECTS THAT THEY SO DESIRE. IF YOU GUYS WANT TO USE
- 11 EVERY DIME WE'VE GOT AT PASADENA HIGH SCHOOL, YOU GUYS CAN
- 12 VOTE IT AND DRIVE HOME, AND THIS COMMITTEE DOESN'T HAVE
- 13 JACK TO SAY ABOUT IT. BUT THE QUESTION AND THE SUBJECT WE
- 14 WERE DISCUSSING WAS HOW WERE THE NUMBERS DERIVED? NOT ARE
- 15 THEY APPROPRIATE, DO WE HAVE JURISDICTION, BUT WHERE DID
- 16 THE NUMBERS COME FROM?
- 17 WHY CAN WE ASK THAT QUESTION? BECAUSE WHEN YOU
- 18 GO READ WHAT IT IS WE'RE SUPPOSED TO DO, IT SAYS THAT THE
- 19 CITIZENS' OVERSIGHT COMMITTEE MEMBERS PLAY A CRITICAL ROLE
- 20 IN ENSURING FISCAL ACCOUNTABILITY AND TRANSPARENCY.
- SO TRANSPARENCY, WHERE DID THE NUMBERS COME FROM?
- 22 IS IT ACCOUNTABLE. WHEN YOU GO DO THE COMPARISON THAT
- 23 CLIFF IS TALKING ABOUT, OBVIOUSLY THE BUDGET THAT WE
- 24 CURRENTLY HAVE POSTED IS GOING TO BE DONE AWAY WITH AT SOME
- 25 POINT, AND BASED ON THE NEW SPEND PLAN, WE'LL COME UP WITH

- 1 A NEW BUDGET. THAT HAS TO HAPPEN. BUT AT THE CURRENT
- 2 MOMENT WE HAVE A BUDGET THAT'S PUBLICLY POSTED.
- 3 AS ONE EXAMPLE -- AND I'M JUST PICKING IT AT
- 4 RANDOM. I DIDN'T STUDY THIS. WE HAD A BUDGET FOR JACKSON
- 5 ELEMENTARY OF 813,000 TO GO IN THE CURRENT REMAINING
- 6 BUDGET. THERE WAS NO PROJECT IN THERE FOR ANYTHING CALLED
- 7 A PARKING LOT DROP-OFF EXPANSION. THAT DID NOT EXIST IN
- 8 THE BUDGET. EVERYTHING IN JACKSON HAS NOW BEEN ELIMINATED
- 9 WHICH IS YOUR RIGHT TO DO WITH THE EXCEPTION OF A PARKING
- 10 LOT DROP-OFF FOR \$1,800,000 WHICH IS A NICE ROUND NUMBER.
- OUR QUESTION IS HOW DID WE COME UP WITH THE
- 12 NUMBER? THAT WAS ALL WE WERE ASKING, NOT THAT IT'S RIGHT
- 13 OR BAD OR WE APPROVE OR DISAPPROVE. BUT IN TERMS OF
- 14 TRANSPARENCY AND ACCOUNTABILITY, HOW DID WE COME UP WITH
- 15 IT? I THINK I HEARD NELSON SAY, AND YOU CAN SAY YEA OR
- 16 NAY, THAT THE STAFF HAS MADE A PROJECTION, AND THAT'S WHAT
- 17 THEY THINK IT WILL BE, AND THEY MAY NOT HAVE ANYTHING MORE
- 18 FIRM THAN THAT. I'M OKAY WITH THAT IF THEY SAY THAT'S WHAT
- 19 IT IS, BUT I'LL ADMIT I'M BOTHERED THAT JACKSON GETS A
- 20 PARKING LOT FOR A MILLION EIGHT.
- 21 BY THE WAY, I THINK THE SWIMMING POOL IS FURTHER
- 22 DOWN THE LIST.
- MS. VANCE: WHATEVER. I DON'T REALLY CARE ABOUT THE
- 24 SWIMMING POOL.
- 25 MR. CAYABYAB: NELSON CAYABYAB.

- 1 WE JUST DON'T TAKE THESE FIGURES FROM OUT OF NO
- 2 WHERE. YOU APPROVE THE DESIGN PROCESS, THE PLANNING
- 3 PROCESS. WE DO THAT. WE HAVE TO BE ABLE TO DO THAT, AND
- 4 IT GOES THROUGH THE PROJECT ESTIMATOR AND SO ON AND SO
- 5 FORTH TO COME UP WITH A PROJECT PROPOSED COST TO BE ABLE TO
- 6 DO THAT PROJECT, DELINEATED BETWEEN HARD COSTS AND SOFT
- 7 COSTS. YOU ALL KNOW THOSE TERMS.
- 8 SO THOSE ARE WHERE THOSE FIGURES ARE COMING FROM.
- 9 IT'S NOT SOMETHING LIKE, HEY, LET'S WAKE UP TOMORROW
- 10 MORNING, NELSON, AND LET'S PUT A PARKING LOT OVER THERE.
- 11 THE CITIZENS WANT IT BECAUSE THERE ARE TRAFFIC ISSUES, DROP
- 12 OFF ISSUES AT JACKSON. SAME THING IS HAPPENING AT SAN
- 13 RAFAEL. SO WE DO THAT SYSTEMATICALLY, AND THEN BECAUSE OF
- 14 THE BID CLIMATE, LIKE I MENTIONED BEFORE, WE ARE PROJECTING
- 15 HOW MUCH THIS BID WILL COME IN AT.
- 16 SO I CAN WAIT UNTIL THE BID PROJECT OR ACTUALLY
- 17 BID OPENING DAY AND LOOK AT THE LOWEST BIDDER AND SAY HERE
- 18 IS THE DIFFERENCE BETWEEN WHAT WE BUDGETED FOR AND THE
- 19 ACTUAL AMOUNT OF THE BID FOR THE CONTRACT. BOARD, YOU
- 20 APPROVED THIS. DO YOU WANT TO DO THIS AND MOVE FORWARD
- 21 WITH IT, AND HERE'S WHERE THE MONEY IS GOING TO COME FROM
- 22 TO SUPPLEMENT THAT ACCORDING TO THE PRIORITY LIST OR NOT.
- 23 THAT'S GOING TO BE THE DECISIONMAKING THAT THE BOARD HAS TO
- 24 MAKE.
- 25 SO THAT'S THE PROCESS FOR US. I MEAN EVERYBODY

- 1 IN CONSTRUCTION AND PROJECT MANAGEMENT KNOW THAT'S HOW WE
- 2 DO THAT. PROJECTIONS, PROJECTIONS, PROJECTIONS AFTER ALL
- 3 THE PLANNING AND THE COST ESTIMATING IS DONE AND THAT'S
- 4 WHAT WE PUT IT FORWARD.
- 5 MS. VANCE: YOU HIT THE NAIL ON THE HEAD WHEN YOU SAID
- 6 PLANNING, AND THAT'S WHAT I'M SAYING. THERE'S NO PLAN. IF
- 7 THERE WAS A PLAN, THEN I WOULD BE GOOD WITH THE
- 8 PROJECTIONS. IF WE'RE GOING TO SAY THIS NEW LIST IS A
- 9 PLANNING -- DID YOU GUYS WATCH NELSON GIVE THE PRESENTATION
- 10 AT THE BOARD MEETING? HE HAD A REASON WHY HE WAS DOING.
- 11 HE HAD AN ALL EDUCATIONAL MASTER THING. IT MAKES SENSE.
- 12 I'M JUST SAYING THAT WE JUST -- IF WE'RE GOING TO HAVE A
- 13 PLAN, LET'S HAVE A PLAN, AND THEN LET'S MOVE FORWARD WITH
- 14 IT. LET'S NOT JUST TAKE A POOL OF MONEY AND GO WE'RE GOING
- 15 TO DO THIS AND WE'RE GOING TO DO THIS AND WE'RE GOING TO DO
- 16 THIS. IT'S NOT FAIR TO THE PEOPLE WHO VOTED FOR THE BOND.
- 17 JUST DECIDE WHAT YOU'RE GOING TO DO, PUT IT IN WRITING AND
- 18 SAY THIS IS OUR NEW PLAN, AND THEN WE HAVE A NEW BUDGET
- 19 NUMBERS TO GO OFF -- RIGHT -- BECAUSE THEY VOTED IN A NEW
- 20 PLAN, AND THIS IS THE BUDGET FOR THIS AND THIS IS THE
- 21 BUDGET FOR THIS, AND THEN WE UNDERSTAND THAT THERE'S GOING
- 22 TO BE CONTINGENCIES AND OVERS AND WHATEVER THERE IS.
- 23 THAT IS JUST MY THING, AND I THINK -- I DON'T
- 24 THINK THAT IT SHOULD BE THE FACILITIES. I THINK IT SHOULD
- 25 BE THE SCHOOL BOARD THAT APPROVES THE PLAN AND WITH INPUT

- 1 FROM THE SCHOOL SITES AND THE PARENTS, BUT THAT'S JUST
- 2 MY -- AND I'M GOING ON A TANGENT. WE REALLY SHOULDN'T TALK
- 3 ABOUT THIS THIS LONG. IT DOESN'T HAVE MUCH TO DO WITH OUR
- 4 OVERSIGHT. IT'S JUST MY FEELING OF ESPECIALLY SITTING IN
- 5 YOUR SEAT WHEN I GAVE MY REPORT OF THE PROMISES THAT WERE
- 6 MADE TO THE VOTERS AND THAT THERE SHOULD BE SOME KIND OF A
- 7 PLAN, AND IF THE SPEND-OUT IS THE NEW PLAN, THEN THAT'S
- 8 OKAY. LET'S JUST MAKE IT THE NEW PLAN. I DON'T KNOW.
- 9 MR. CAYABYAB: NELSON CAYABYAB.
- 10 LASTLY, JUST TO FURTHER AMPLIFY, WHEN WE DID THE
- 11 PRIORITY LIST, WE LOOKED AT THREE THINGS. CODE
- 12 REQUIREMENTS IS THE NUMBER ONE PRIORITY. SECOND PRIORITY
- 13 IS FIRE-LIFE SAFETY. THAT INCLUDES SEISMIC RETROFITTING
- 14 FOR THE KIDS SO THEY CAN COMFORTABLY GET OUT OF THE
- 15 BUILDINGS ON TIME. THEN AFTER INTO THE CLASSROOMS WAS
- 16 NEEDED. SO WE PRIORITIZED THOSE NEEDS OUT OF THOSE THREE
- 17 CRITERION ON THINGS THAT NEEDED TO BE DONE AT THE REMAINING
- 18 OF THE SCHOOL SITES. THAT'S WHAT WE GET FROM THE
- 19 FEASIBILITY STUDY AND THINGS LIKE THAT. SO IT'S NOT
- 20 SOMETHING THAT WE JUST KIND OF THROW OUT. IT'S SYSTEMATIC.
- 21 THOSE ARE THE THREE THINGS THAT WE NEED TO MEET FOR THAT,
- 22 AND SO THAT'S HOW WE CAME UP WITH THE PRIORITY LIST.
- MS. WANG: THIS IS JEN.
- I HAVE A QUESTION. THOSE PRIORITY AFTER YOU
- 25 BRING THE PROJECT UP TO MEET THOSE CRITERIA, DO YOU GET THE

- 1 BOARD APPROVE OR YOU JUST GO AHEAD AND EXECUTE IT WITHOUT
- 2 THE KNOWLEDGE FROM THE BOARD?
- 3 MR. CAYABYAB: NELSON CAYABYAB.
- 4 THAT'S WHAT THE BRIEFING WAS FOR THAT I
- 5 MENTIONED, AND THIS IS WHAT I RECOMMENDED THE PRIORITY IS
- 6 GOING TO BE, 1 THROUGH 27, AND WE PROVIDED AN INPUT FOR THE
- 7 BOARD TO PROVIDE INPUT TO CHANGE THOSE PRIORITIES THE WAY
- 8 THEY SEE FIT, AND THAT'S WHAT WE ARE STILL WORKING ON NOW.
- 9 THAT'S THE PROCESS FOR US. AND THEN WE ALWAYS HAVE TO
- 10 ATTACH A NUMBER TO THAT, AND THAT'S WHERE WE GET THE
- 11 SPEND-OUT PLAN OF WHAT WE THINK THE PROJECT IS GOING TO
- 12 COST. THAT IS NOT GOING TO BE THE REAL COST UNTIL WE GET
- 13 TO BID OPENING DAY WHEN THE PROJECT COMES IN. THIS GIVES
- 14 YOU A PROCESS FOR THE BOARD TO MAKE A DECISION. THE SAME
- 15 THING THAT'S IMPORTANT TO THE MEMBERS OF THE BOARD IS WHERE
- 16 IT IN THE DSA APPROVAL PROCESS? IF YOU PUT SOMETHING AT A
- 17 LOW PRIORITY AND THAT IS ALREADY OUT OF DSA, YOU'VE WASTED
- 18 ALL THAT MONEY ON THE FEES, SOFT COSTS OF YOU TRYING TO GET
- 19 THAT PROJECT. THAT'S WHY THE BOARD DECIDED TO STAY WITH
- 20 THE TOP EIGHT OR NINE PROJECTS AND MOVE FORWARD WITH THEM
- 21 FIRST BEFORE YOU START LOOKING AT 10 THROUGH 27.
- 22 MS. VANCE: I DIDN'T SEE THE BOARD MAKING THAT VOTE.
- 23 DID THE BOARD VOTE TO DO THAT? TO PRIORITIZE THE TOP NINE?
- 24 WAS THERE A VOTE?
- MS. KENNE: I'M GOING TO SAY YES, BUT IT CERTAINLY WAS

- 1 DIRECTION GIVEN TO THE STAFF AT A PUBLIC BOARD MEETING.
- 2 I'M TRYING TO REMEMBER. IT WAS A STUDY SESSION.
- 3 MR. CAYABYAB: NELSON CAYABYAB.
- 4 YEAH. THE FIRST NINE WAS TO MOVE FORWARD BECAUSE
- 5 THEY'RE SO FAR ALONG ALREADY, EITHER CONTRACTED OR OUT OF
- 6 DSA. YOU RECOMMENDED TO MOVE FORWARD.
- 7 MS. KENNE: YEAH. I JUST DON'T REMEMBER IF WE TOOK A
- 8 FORMAL VOTED OR JUST KIND OF GAVE DIRECTION TO STAFF
- 9 BECAUSE OFTEN, PERHAPS TOO OFTEN, THAT'S WHAT HAPPENS AT A
- 10 BOARD MEETING. BUT IT WAS AT THE --
- 11 MS. VANCE: IT WAS A SPECIAL MEETING.
- 12 MS. KENNE: APRIL STUDY SESSION.
- 13 MS. VANCE: WHICH IS END OF MARCH.
- MR. CAYABYAB: NELSON CAYABYAB.
- 15 I WILL FORMALIZE IT PROBABLY IN JULY WITH THE
- 16 LIST OF PRIORITIES WITH THE MORE LEGITIMATE OR AS CLOSE AS
- 17 WE CAN GET IT ON THE SPEND-DOWN SHEET AS TO HOW MUCH EACH
- 18 OF THESE PROJECTS WILL COST. THAT WILL GO UP FOR A VOTE IN
- 19 JULY.
- 20 MS. KENNE: THIS IS KIM.
- 21 WHAT I'LL SAY, YOU KNOW, THIS IS -- I'VE KIND OF
- 22 BEEN LOOKING AT TT FROM THE OUTSIDE FOR A LONG TIME. WHEN
- 23 I LOOK AT THIS, I THINK ABOUT HOW THE MONEY WAS ALLOCATED
- 24 IN 2012, AND THERE WERE BIG CHUNKS GIVEN TO SITES, IF YOU
- 25 WILL, WITH KIND OF A LIST OF DESIRED WORK. WHEN -- OR BACK

- 1 IN 2008 I SHOULD SAY.
- 2 IN 2012 WHEN IT BECAME APPARENT THERE WASN'T AS
- 3 MUCH MONEY, THE MONEY FOR EACH SITE CHANGED, AND THE WORK
- 4 HAD TO CHANGE AS WELL. THAT'S A LITTLE BIT DIFFERENT WITH
- 5 THIS WHERE I FEEL A LITTLE BIT MORE LIKE WE'RE SAYING WE'RE
- 6 AGREEING TO DO A PROJECT, AND WE'RE PUTTING AN ESTIMATE ON
- 7 IT, AND IF THE ESTIMATE IS WRONG AND TOO LOW AND IT GOES
- 8 UP, WE WILL STILL SPEND ALL OF THAT MONEY. WE'RE NOT GOING
- 9 TO GO BACK AND MAKE THAT PROJECT SMALLER. IT'S A SLIGHTLY
- 10 DIFFERENT WAY OF LOOKING AT IT NOW WHERE WE ARE WITH THE
- 11 BONDS.
- MS. VANCE: GRETCHEN.
- 13 SO IS THE PLAN THEN FOR YOUR NEXT BOND TO SAY
- 14 WE'RE JUST GOING TO PAY FOR THE REST OF THE STUFF THAT WE
- 15 DIDN'T GET PAID FOR?
- 16 MS. RAHN: POTENTIALLY.
- 17 MS. KENNE: I'M NOT CLEAR THAT'S BEEN DECIDED QUITE
- 18 YET.
- 19 MS. VANCE: I KNOW YOU'RE PREPARING -- RIGHT --
- 20 ALREADY FOR THE NEXT BOND? I THINK THERE WERE SOME EMAILS
- 21 THAT WENT BACK AND FORTH. SO ARE WE GOING TO HAVE -- I'M
- 22 JUST CURIOUS.
- MS. KENNE: BUT, AGAIN, DON'T FORGET THIS DISTRICT HAS
- 24 CHANGED IN SIZE IN NUMBER OF STUDENTS AND WHERE STUDENTS
- 25 ARE AND WHERE PROGRAMS ARE A LOT FROM THE LAST -- SO THE

- 1 LAST TIME WE THOUGHT ABOUT WHERE MONEY SHOULD GO WAS 2008.
- 2 BECAUSE 2012 WASN'T THE
- 3 LET'S-LOOK-AT-HOW-THE-DISTRICT'S-CHANGED-AND-REALLOCATE-
- 4 MONEY. IT WAS JUST LIKE EACH GOT LESS.
- 5 MS. VANCE: THAT WAS JUST A CUT, STRAIGHT CUT.
- 6 MR. COLE: THIS IS STEVE COLE.
- 7 COMING FROM A SCHOOL SITE THAT HAD THE OLDER
- 8 METHOD OF WE'RE JUST GOING TO CHOP, YOU KNOW, DOWN THE
- 9 PROJECT, DOWN THE PROJECT, DOWN THE PROJECT, THIS SEEMS
- 10 LIKE A MUCH FAIRER WAY OF DOING IT FROM MY PERSPECTIVE,
- 11 COMMITTING TO AN ACTUAL PROJECT AND FIXING IT AND FINISHING
- 12 AN ACTUAL PROJECT AS OPPOSED TO JUST LOBBING IT DOWN. I
- 13 KIND OF WISH IT WAS DONE THIS WAY FROM THE BEGINNING TO BE
- 14 HONEST.
- 15 MS. VANCE: RIGHT.
- 16 MR. RAHN: THIS IS MIKALA RAHN.
- BUT THAT'S ONLY IF YOU'RE ON THE TOP LIST.
- 18 MS. VANCE: THAT'S WHAT I JUST WAS GOING TO SAY. YOU
- 19 MUST BE ONE OF THE TOP NINE.
- 20 MR. CATES: LADIES, ONE AT A TIME.
- MR. COLE: I AGREE WITH YOU.
- 22 MS. RAHN: IT'S MY TURN. THE ISSUE IS, STEVE, AT THIS
- 23 POINT -- LET'S GO BACK TO BASICS. THE BASICS ARE THERE IS
- 24 NO MASTER PLAN FOR THE DISTRICT. THERE IS NO FACILITIES
- 25 PLAN. THEREFORE, WHERE WE'RE AT NOW, NELSON, IS DOING THE

- 1 BEST JOB HE CAN.
- 2 MR. COLE: I AGREE.
- 3 MS. RAHN: SO I MEAN WE CAN ARGUE THAT POINT IF WE
- 4 WANT, BUT I DON'T THINK IT'S WORTH IT. IT'S THAT HERE WE
- 5 ARE WITH THIS LOCOMOTIVE GOING DOWN, AND SOME PROJECTS ARE
- 6 GOING TO GET RIPPED OFF, AND OUR ONLY PROBLEM HERE IS WE
- 7 DON'T EVEN KNOW WHAT DOLLAR AMOUNT WE'RE AT OR WHAT -- I
- 8 ASSUME HE KNOWS, BUT WE, AS THE CITIZENS' OVERSIGHT, DON'T
- 9 KNOW WHEN THAT CRASH COMES, AND THAT'S ALL WE HAVE TO BE
- 10 FOCUSED ON.
- 11 SO SOMETIMES I THINK WE GET INTO THE MINUTIAE OF
- 12 THIS WHEN IF WE GO BACK TO THE START OF THE MEETING, WE
- 13 JUST SAY THERE'S NO PLAN. SHE'S ABSOLUTELY RIGHT. I WAS
- 14 THE MASTER PLANNING CHAIR. I SAW IT. I MEAN, ON RECORD.
- 15 MEANING LIKE I DIDN'T GET ANYTHING DONE. EVERYTHING IS
- 16 STILL GOING. SO WE HAVE NO MASTER PLAN. WE HAVE NO
- 17 FACILITIES PLAN. WE HAVE SOMEONE TRYING TO MANAGE THE END
- 18 OF THE WORK. AND SOME PEOPLE ARE GOING TO GET MAJORLY
- 19 RIPPED OFF, AND WE HAVE NO IDEA FROM OUR PERSPECTIVE WHEN
- 20 THAT'S GOING TO HIT. THAT'S IT. A LOT OF THIS STUFF ISN'T
- 21 EVEN WORTH TALKING ABOUT BECAUSE THAT'S THE BIG PICTURE.
- 22 MR. COLE: RIGHT. THIS IS STEVE.
- BUT ALL I WAS TRYING TO SAY WAS AS A FUNCTION OF
- 24 HOW IT'S CURRENTLY GOING NOW, I THINK THE WAY THAT SPENDING
- OUT THE CURRENT MONEY, THIS IS AN APPROPRIATE WAY TO DO IT

- 1 AS OPPOSED TO HOW IT WAS BEFORE, AND AS LONG AS THAT'S LAID
- 2 OUT FOR EVERYBODY AHEAD OF TIME AND A LOT OF IT JUST
- 3 COMMUNICATION.
- 4 MS. RAHN: BUT, STEVE, I DON'T THINK WE AGREE IN THIS
- 5 ROOM THAT IT'S LAID OUT.
- 6 MR. COLE: RIGHT. BUT I'M SAYING --
- 7 MS. RAHN: IF WE DON'T EVEN KNOW THE BOTTOM LINE
- 8 DOLLAR AMOUNTS --
- 9 MR. COLE: SURE.
- 10 MS. RAHN: -- THEN US AS A COMMITTEE, YOU MIGHT KNOW,
- 11 NELSON MIGHT KNOW, SOMEBODY ELSE MIGHT KNOW, BUT AS A
- 12 COMMITTEE WITH OUR WORK TO DO, WE DON'T KNOW, AND I'M NOT
- 13 EVEN BLAMING ANYONE FOR THAT. I'M JUST SAYING THAT IS THE
- 14 CURRENT SITUATION WE'RE OPERATING UNDER.
- 15 MR. COLE: RIGHT. AND I AGREE WITH YOU.
- MS. RAHN: SOMEONE IS GOING TO BE REALLY PISSED OFF AT
- 17 US SOON.
- 18 MS. VANCE: BACK TO GRETCHEN.
- 19 THAT'S MY POINT. IS THAT WHEN THE MONEY RUNS
- 20 OUT, YOU KNOW WHO EVERYBODY IS GOING TO COME TO? LOOK
- 21 AROUND.
- 22 MR. CATES: WHY DO YOU THINK THAT I INSISTED ON A
- 23 VERBATIM TRANSCRIPT. THEY COME US TO, AND I'LL SAY HERE'S
- 24 THE TRANSCRIPT. WE DID THE BEST WE COULD.
- 25 BY THE WAY, NELSON, YOUR PROPOSAL IN THE

- 1 SPEND-OUT PLAN IS NOT SOMETHING WE'RE CRITICIZING. IT'S A
- 2 LOGICAL STEP TO TAKE. YOU HAVE 122 MILLION OR WHATEVER IT
- 3 IS LEFT.
- 4 MR. COLE: MAN, YOU DIDN'T GET YELLED AT. SORRY.
- 5 MR. CATES: AND YOU'RE PRIORITIZING IT, AND THE
- 6 SPEND-OUT PLAN IS A RECOMMENDATION TO THE BOARD. RIGHT?
- 7 THE BOARD'S GOT TO DEAL WITH IT. WE'RE IN THE POSITION OF
- 8 NOT BEING ABLE TO JUDGE THE OVERALL TT EXPENDITURES BECAUSE
- 9 WE DON'T KNOW IF WHAT YOU HAVE PROPOSED IS WHAT THE BOARD
- 10 HAS APPROVED OR WILL APPROVE. SO WE'RE LOOKING AND SAYING
- 11 IS IT ALPHA OR IS IT OMEGA OR SOMETHING IN BETWEEN?
- MS. RAHN: ONE MORE THING. AND, STEVE, THIS IS WHY
- 13 IT'S FRUSTRATING.
- 14 MR. COLE: SURE.
- 15 MS. RAHN: I THINK ONE OF THE THINGS THAT IS A PROBLEM
- 16 BEING ON THIS CSC, BECAUSE I'VE WORN THE FACILITIES HAT,
- 17 AND SO I LOVE THAT IT'S VERBATIM BECAUSE WE HAVE TO BE
- 18 CAREFUL WHEN WE SIT IN A SCHOOL SITE AND ADVOCATE FOR A
- 19 SCHOOL SITE BECAUSE IN THE END THEY'RE GOING TO READ THIS.
- 20 SO THE FACT THAT LET'S -- I'M JUST GOING THEORETICAL.
- 21 SIERRA MADRE, PHS MIGHT BE WINNING. BLAIR MIGHT WIN.
- 22 WHERE IS JACKSON? SO WE JUST HAVE TO BE CAREFUL. I HAVE
- 23 NO STAKE IN IT. I DON'T EVEN HAVE A CHILD IN THE DISTRICT
- 24 AT THIS POINT. SO WE NEED TO BE CAREFUL ON TAPE BECAUSE
- 25 THERE'S GOING TO BE SOME LOSERS.

- 1 MR. COLE: ABSOLUTELY. THIS IS STEVE COLE.
- 2 WHAT I WAS TRYING TO SAY IS ORIGINALLY, YOU KNOW,
- 3 WHEN THE MONEY WAS ALLOCATED IN 2008, THAT WAS FINE. WHEN
- 4 THE MONEY STARTED BEING CUT, I WISH INSTEAD OF PROJECTS
- 5 BEING CUT ACROSS THE BOARD, MORE OF THIS PROCESS WAS PUT
- 6 INTO PLACE TRANSPARENTLY OF WE'RE GOING TO FINISH THESE
- 7 PROJECTS MOVING DOWN AND THAT EVERYBODY KNEW IT TO BEGIN
- 8 WITH. SO IF SOMEBODY READS THIS TRANSCRIPT VERBATIM,
- 9 GREAT. I'M HAPPY WITH THAT. LET'S GET IT OUT THERE, AND
- 10 LET THEM KNOW YOU'RE AT THE BOTTOM OF THE LIST, YOU KNOW,
- 11 AND THIS IS WHAT IS COMING OUT. THEY'RE GOING TO BE MAD.
- 12 I WAS MAD. I'M, YOU KNOW, STILL HARBORING EMOTIONAL SCARS
- 13 OVER IT. BUT BASICALLY GETTING THAT INFORMATION OUT AND
- 14 GETTING TO KNOW THAT, LOOK, THIS IS HOW THE PRIORITIES ARE
- 15 WORKING. THAT I THINK IS THE IMPORTANT PART.
- 16 MS. VANCE: GRETCHEN.
- 17 AND THAT'S MY POINT IS THAT IF WE WANT TO GO TO
- 18 THE SCHOOL SITES AND SAY THIS IS THE LIST, THIS IS WHAT THE
- 19 BOARD HAS APPROVED AS THE LIST, I JUST NEED TO KNOW IS IT
- 20 WHAT THE BOARD HAS APPROVED ON THE LIST SO THAT I CAN GO TO
- 21 MY NEXT PHS SCHOOL SITE COUNCIL AND GO, GUESS WHAT, IT'S
- 22 BEEN APPROVED. YOUR POOL IS NO. 17. FAT CHANCE. YOU'RE
- 23 PROBABLY NOT GOING TO GET YOUR POOL. JUST SO THAT --
- MS. RAHN: BUT, AGAIN, I'M ON AN AGENDA ITEM ABOVE
- 25 THAT. I DON'T WANT A LIST WITHOUT KNOWING THE NUMBERS. SO

- 1 I DON'T WANT TO LOOK AT A LIST OF WHAT THEY'RE GOING TO
- 2 POTENTIALLY PRIORITIZE BECAUSE WE -- AGAIN, NELSON MIGHT
- 3 KNOW -- WE DON'T KNOW HOW MUCH THEY HAVE LEFT.
- 4 MS. VANCE: RIGHT.
- 5 MS. RAHN: SO WITHOUT US KNOWING THE PAST, WE CAN'T
- 6 EVEN TELL ANYONE THE FUTURE. IT WOULD BE IRRESPONSIBLE FOR
- 7 US TO DO THAT. SO FOR ME I'M STILL BACK UP AT THE OTHER
- 8 ITEMS. YOU KNOW, WE NEED TO JUST DO THIS ONE STEP AT A
- 9 TIME. IF KIM IS SAYING PROGRESS WILL BE MADE IN JUNE, THEN
- 10 THE TRUTH IS JUST CUT OUT MOST OF THE ITEMS ON THIS AGENDA.
- 11 JUST CROSS THEM OFF BECAUSE WE NEED THAT STEP TO BE EVEN
- 12 ABLE TO BE INFORMED TO HAVE THE CONVERSATION.
- 13 MS. VANCE: I AGREE.
- 14 MS. RAHN: I WOULD TAKE EVERY FINANCE ITEM OFF THE
- 15 AGENDA TONIGHT. THAT'S WHAT I PROPOSE BECAUSE WITHOUT THE
- 16 INFORMATION THAT KIM IS SAYING WE ARE GOING TO HAVE IN
- 17 JUNE, WE CAN'T MAKE AN INFORMED DECISION OR DISCUSSION.
- 18 MR. HOCUTT: QUINCY.
- 19 I'M CONFUSED. WHAT ARE WE GOING TO HAVE IN JUNE?
- 20 MS. RAHN: YOU GUYS ARE GOING TO HAVE THE REPORT.
- MR. HOCUTT: IT DOESN'T FIX THIS. I MEAN, FRANKLY, I
- 22 DON'T KNOW WHY WE'RE CONFUSED. NELSON HAS MADE A PRIORITY
- 23 LIST. I DON'T HAVE A PROBLEM WITH IT BECAUSE I DON'T KNOW.
- 24 I DON'T CARE IF PASADENA IS 1ST OR 32ND, BUT HE'S GOT A
- 25 LIST. HE'S GOT IT IN ORDER, AND HE'S GOT NUMBERS ATTACHED

- 1 TO IT, AND IT ADDS UP TO 126 MILLION. THERE IT IS. BUT
- 2 THE QUESTION ON THIS AGENDA ITEM WAS HOW DO WE COME UP WITH
- 3 THE NUMBERS ON THE LIST, AND NELSON HAS SAID THAT HE'S GOT
- 4 ALL KINDS OF DATA WHICH GOES RIGHT BACK TO WHERE IS THE
- 5 DATA OR IS IT JUST AN ALLOCATION? I DON'T KNOW. THAT'S
- 6 WHAT THIS WAS TO FIND OUT. WHAT ARE THE NUMBERS?
- 7 MS. KENNE: THIS IS KIM.
- 8 SO IT SOUNDS LIKE NELSON HAS ANSWERED THE
- 9 QUESTION THAT THIS WAS POSING, AND WE DID KIND OF BRING UP
- 10 ISSUES AROUND IT, BUT I DO THINK TO GRETCHEN'S POINT WHEN
- 11 THE BOARD APPROVES HOW THE REST OF TT WILL BE SPENT, THERE
- 12 IS COMMUNICATION, AND WHETHER THAT'S SOMETHING THAT THIS
- 13 COMMITTEE DOES OR STAFF DOES OR THE BOARD DOES FOR ANY ONE
- 14 WHO THOUGHT THEY WERE GETTING SOMETHING WHO ISN'T ANYMORE
- 15 WHO IS NOW GETTING SOMETHING THAT THEY SHOULDN'T HAVE BEEN
- 16 EXPECTING BECAUSE, YOU KNOW, IT WASN'T ON THE 2012 PLAN.
- 17 SO I MEAN THERE IS A COMMUNICATION PIECE AFTER
- 18 THE APPROVAL, AND SINCE HALF OF IT IS KIND OF APPROVED NOW,
- 19 I MEAN, THAT SHOULD BE PUBLICIZED AS WELL. BUT I
- 20 THINK -- I THINK EVERYTHING THAT IS BEING WORKED ON AT THE
- 21 TOP HALF WAS ON 2012 SO IT'S NOT A SURPRISE. WE DIDN'T
- 22 KICK ANYONE OFF YET.
- MR. HOCUTT: QUINCY.
- 24 IF I MAY, ONCE THE BOARD APPROVES THIS, AND THEY
- 25 WILL APPROVE SOME VARIANT OF THIS, THEY HAVE TO, THEN THIS

- 1 WILL BE TURNED INTO A BUDGET REPORT WHICH WILL LOOK LIKE
- 2 THIS THING, AND THE QUESTION GOES RIGHT BACK TO ONCE WE NOW
- 3 HAVE THE BUDGET REPORT, HOW DOES THE WORLD KNOW THAT INDEED
- 4 WE ARE DOING THIS CORRECTLY AND WITHIN BUDGET AND ON TIME,
- 5 ET CETERA. THE BUDGET REPORT AS IT EXISTED DIDN'T TELL US
- 6 THAT. SO THE WHOLE REASON FOR THE NEW REPORT IS WE HAVE A
- 7 BUDGET. HOW IS IT WORKING?
- 8 MS. KENNE: AND IT WILL FLOW RIGHT IN.
- 9 MR. HOCUTT: AND IT WILL FLOW RIGHT IN. BY THE WAY,

- 12 MR. HOCUTT: SORRY.
- 13 MS. VANCE: GRETCHEN.
- 14 SO I HAVE A QUESTION FOR NELSON. SO ARE THERE
- 15 BUDGET NUMBERS ENTERED INTO COLBY INTO ACCOUNTABILITY? ARE
- 16 BUDGETS NUMBERS ENTERED INTO THAT? WERE THEY ENTERED INTO
- 17 THAT PROGRAM?
- 18 MR. CAYABYAB: NELSON.
- 19 YES.
- MS. VANCE: ARE THOSE FROM THE 2012 MASTER PLAN?
- MR. CAYABYAB: THEY WERE FROM THE ORIGINAL BUDGET WE
- 22 WERE WORKING ON, YES.
- MS. KENNE: I DON'T WANT TO GO INTO DETAILS, BUT I'LL
- 24 TALK TO YOU AFTERWARDS BECAUSE THERE'S MORE THAN ONE BUDGET
- 25 FIELD.

- 1 MR. CATES: LET ME POSE THIS QUESTION TO THE COMMITTEE
- 2 BECAUSE ALTHOUGH I UNDERSTAND SEPARATELY WHAT EACH OF YOU
- 3 HAS SAID, I'M NOT SURE THAT I UNDERSTAND THAT WE'VE REACHED
- 4 ANY CONCLUSION. WE HAVE THE ABILITY TO RECOMMEND ACTION TO
- 5 THE BOARD. OTHER THAN PLEASE ADOPT A FACILITIES MASTER
- 6 PLAN, WHAT DO WE WANT?
- 7 MR. HOCUTT: QUINCY. CAN I TRY TO ANSWER AND THEN YOU
- 8 SAY YEA OR NO. I THINK WHAT WE WANT IS FOR THE BOARD TO
- 9 SAY THE SPEND-OUT PLAN THAT NELSON HAS PROPOSED AND THE
- 10 ORDER THAT HE HAS PROPOSED WITH THE NUMBERS THAT HE'S
- 11 PROPOSED IS ACCEPTABLE, AND IF THEY VOTE 8 TO ZERO OR
- 12 WHATEVER, WE HAVE A NEW BUDGET. THAT'S IT.
- 13 MS. VANCE: COULDN'T WE CALL THAT A NEW MASTER PLAN?
- 14 MS. RAHN: HOW DO YOU HAVE A NEW BUDGET WHEN WE DON'T
- 15 KNOW WHAT THE BALANCE IS?
- MR. HOCUTT: THE BALANCE IS 126 MILLION.
- 17 MS. KENNE: THERE'S NO DOUBT ABOUT THAT.
- 18 MS. RAHN: YOU FEEL GOOD ABOUT THAT WITH THE PROJECTED
- 19 OVERRIDES AND THIS, THAT, OR WHATEVER?
- 20 MS. KENNE: I FEEL GOOD THAT THERE'S THAT MUCH
- 21 UNSPENT.
- MS. RAHN: THAT'S A LOW BAR.
- MS. KENNE: HEY, BUT THERE IS A BAR SO THAT'S GOOD.
- 24 WE'LL GO FROM THERE.
- 25 MR. CATES: THE SPEND-OUT PLAN ISN'T REALLY A BUDGET.

- 1 IT'S AN ALLOCATION OF REMAINING FUNDS, AND WHAT WE NEED TO
- 2 BE ABLE TO DO OUR JOBS, I THINK, IS A BUDGET THAT'S BEEN
- 3 APPROVED BY THE BOARD. NELSON'S DONE ALL THAT HE CAN DO.
- 4 YOU KNOW, WE HAVE 126 MILLION LEFT, AND WE HAVE TO FINISH
- 5 NINE PROJECTS THAT ARE SUBSTANTIALLY COMPLETE, AND HERE'S
- 6 MY RECOMMENDATION FOR SPENDING THE REST. SO IT SEEMS TO
- 7 ME, CORRECT ME IF I'M WRONG, THAT WE'RE ASKING THE BOARD TO
- 8 ACT, TO ACT ON THE SPEND-OUT PLAN.
- 9 MS. KENNE: AND WE WILL AS SOON AS STAFF BRINGS IT TO
- 10 US WHICH I THOUGHT MIGHT BE JUNE, BUT NOW IT SOUNDS LIKE
- 11 IT'S JULY.
- 12 MR. CAYABYAB: I CAN BRING IT IN JUNE. IT'S NOT A
- 13 PROBLEM.
- 14 MS. KENNE: JUST DON'T -- TYPICALLY WE ONLY HAVE ONE
- 15 MEETING IN JULY AT THE VERY END, SO DEPENDING ON WHAT
- 16 TIMING, BUT JUNE IS BUDGET MONTH.
- MR. CAYABYAB: JUST ONE ADVERTISING. WE'RE STARTING
- 18 UP A CONSOLIDATION AND BOUNDRY COMMITTEE AND ALSO LOOKING
- 19 AT THE CAPACITIES FOR EACH OF THE SCHOOLS, AND THAT WILL
- 20 HAVE AN IMPACT, DEPENDING ON WHAT WE DECIDE, WHAT THE
- 21 EDUCATIONAL MASTER PLAN, WHAT PROGRAMS GOES WITH WHICH
- 22 SCHOOLS AND WHAT SCHOOLS ARE RECOMMENDED TO BE CLOSED OR
- 23 NOT CLOSED. THAT TYPE OF THING.
- 24 WE'RE GOING TO BE SENDING OUT APPLICATIONS FOR
- 25 THAT, SO IF YOU WANT TO GET INVOLVED WITH THAT, PLEASE DO

- 1 BECAUSE THAT HAS AN IMPACT ON HOW WE SPEND THE REST OF OUR
- 2 MONEY AS FAR AS THE LIST OF PRIORITIES. OKAY? SO JUST A
- 3 LITTLE BIT OF ADVERTISING.
- 4 MR. CATES: HOW DO WE AVOID THE CIRCULARITY PROBLEM?
- 5 THAT BEING WE CAN'T GIVE YOU A NUMBER UNTIL WE GET MORE
- 6 INPUT, BUT WE CAN'T GET MORE INPUT UNTIL WE PROVIDE A
- 7 NUMBER.
- 8 MR. CAYABYAB: NO. YOU'RE GOING TO GET THE NUMBERS.
- 9 THAT'S NOT WHAT I'M SAYING. IT'S A DISTRICT -- WE'RE
- 10 PLANNING FOR THE LONG TERM TYPE OF THING. THAT'S WHY WE'RE
- 11 KIND OF DOING ALL OF THIS CONSOLIDATION AND BOUNDRY. YOU
- 12 WILL GET, YOU WILL GET THE NUMBERS ACCORDING TO THE
- 13 PRIORITIES THAT IS GOING TO BE APPROVED BY THE BOARD. BUT,
- 14 AGAIN, THOSE NUMBERS ARE JUST PROJECTED ALLOCATION. THE
- 15 REAL NUMBERS WILL COME IN WHEN THE BID OPENING COMES UP.
- 16 OKAY?
- 17 MR. CATES: I THINK I HEARD YOU SAY THAT YOU'LL BE

- 1 MS. VANCE: GRETCHEN.
- 2 BUT I THINK WHAT NELSON SAID IS THERE'S A CAVEAT
- 3 TO THAT BECAUSE THEY HAVE TO CREATE ANOTHER COMMITTEE
- 4 BEFORE THEY'RE ACTUALLY GOING TO HAVE THOSE NUMBERS; RIGHT?
- 5 MR. CAYABYAB: NO. I'LL HAVE THE NUMBERS FOR THE
- 6 REMAINING 126 MILLION. IT'S REALLY JUST TO IDENTIFY THE
- 7 NUMBERS FOR THE REMAINING 124, 126 MILLION THAT WE HAVE TO
- 8 SPEND, AND IT'S REALLY A PREAMBLE FOR THE NEXT BOND.
- 9 MR. CATES: AM I CORRECT IN ASSUMING THAT WE HAVE
- 10 NOTHING SPECIFIC TO RECOMMEND TO THE BOARD AT THIS POINT?
- 11 IT'S EASY TO RECOMMEND. I JUST WRITE A LETTER, BUT I
- 12 WOULDN'T HAVE A CLUE WHAT TO WRITE.
- 13 MS. VANCE: I ALREADY WROTE THEM A LETTER.
- 14 MR. CAYABYAB: I HAVE A SUGGESTION. NELSON CAYABYAB.
- 15 SINCE THE FIRST NINE OR EIGHT, WHATEVER ON THE
- 16 PRIORITY LIST IS A MUST-DO THING, RECOMMEND THAT THESE
- 17 PROJECTS BE DONE FIRST AS PER PRIORITY LIST.
- 18 MR. CATES: WELL, I CAN'T SPEAK FOR THE COMMITTEE, BUT
- 19 I'M WILLING TO TAKE YOUR WORD THAT THESE NINE PROJECTS ARE
- 20 PRIORITY PROJECTS AND NEED TO BE FINISHED.
- 21 MR. HOCUTT: QUINCY.
- I WOULD AGREE WITH THAT. I MEAN, I HAVE NO

- 1 MS. VANCE: I'M NOT GOING TO AGREE TO THAT THEN.
- 2 SORRY.
- 3 MR. HOCUTT: THAT LEAVES 24 MILLION FOR THE BOARD TO
- 4 PRIORITIZE.
- 5 MR. CATES: OKAY.
- 6 MR. CAYABYAB: THAT'S WHY I RECOMMENDED NINE PROJECTS.
- 7 MR. CATES: SO THE NINE PROJECTS WILL EAT UP 83
- 8 PERCENT OF THE REMAINING FUNDS.
- 9 ANYTHING ELSE MORE ON ITEM III D, THE SPEND-OUT
- 10 PLAN, THE MASTER PLAN, BUDGET?
- 11 ALL RIGHT. WE'VE BEEN AT IT FOR 90 MINUTES.
- 12 ALTERNATIVES ARE FIVE-MINUTE BREAK, A TEN-MINUTE BREAK, OR
- 13 NO BREAK. DOES ANYONE WANT A BREAK?
- 14 MS. VANCE: I WANT A BREAK.
- 15 MR. CATES: WE'LL TAKE A FIVE-MINUTE BREAK.
- 16 (A RECESS WAS TAKEN.)
- 17 MR. CATES: LET'S RESUME. WE'RE ON III D II.
- 18 GLENN --
- 19 MS. RAHN: NO. I THINK WE'RE ON III D III.
- 20 MR. CATES: III D III.
- MS. RAHN: BECAUSE II IS RELATED.
- 22 MR. CATES: MIGUEL INFORMED US THAT HE WAS UNABLE TO
- 23 FIND ANY LAW OR REGULATION REQUIRING THREE SEPARATE BIDS.
- 24 I THINK THE POINT HAS BEEN MADE. I DON'T KNOW THAT WE NEED
- 25 TO BELABOR THIS FURTHER UNLESS SOMEONE WANTS TO.

- 1 MS. VANCE: GRETCHEN.
- 2 MY ONLY COMMENT IS ISN'T THAT -- IS THAT RELATED
- 3 TO THE CALL OUT -- I DON'T KNOW WHAT IT'S
- 4 CALLED -- NOTATION IN THE AUDIT? NO? HAS NOTHING TO DO
- 5 WITH IT? OKAY. NEVER MIND. BECAUSE I THOUGHT THEY MADE A
- 6 COMMENT ABOUT NOT GETTING BIDS ON IT. MAYBE THAT WAS A
- 7 CHANGE OVER.
- 8 MR. DEVEER: GLENN DEVEER.
- 9 WE WERE TALKING ABOUT THE SYNTHETIC TRACKS, AND
- 10 THERE WAS SOME COMMENT MADE BY FACILITIES THAT SAID DSA
- 11 WON'T ALLOW US TO USE THE SAME TRACK OR THE SAME
- 12 SPECIFICATIONS FOR THIS TRACK ON THREE DIFFERENT VARIOUS
- 13 PROJECTS EVEN THOUGH THEY'RE THE SAME, AND MIGUEL WAS GOING
- 14 TO BRING SOME DOCUMENTATION TO US SAYING, YES, WE COULD,
- 15 BUT THAT'S NEVER HAPPENED.
- 16 MR. CATES: OKAY.
- 17 MR. CAYABYAB: REALLY, YOU CAN'T. BECAUSE WHAT WE'RE
- 18 DOING NOW WITH THE THREE ATHLETIC TRACKS IS THAT WE'RE
- 19 TRYING TO GET A C MASS TO PURCHASE AND INSTALL JUST THE
- 20 TRACKS THEMSELVES. NOW, IF YOU'RE REQUIRING TO HAVE ALL OF
- 21 THESE ON THREE BIDS ON ONE GENERAL CONTRACTOR, IT'S

- 2 THERE. YOU CAN'T DO THAT. IT'S PUBLIC WORKS THAT YOU HAVE
- 3 TO DO IT SEPARATELY.
- 4 MR. CATES: ALL RIGHT.
- 5 MR. HOCUTT: CAN I ASK ONE QUESTION ABOUT THAT? GOING
- 6 BACK TO WHERE-DO-THE-NUMBERS-COME-FROM QUESTIONS, ON THE
- 7 LIST OF THOSE PRIORITIES THOSE THREE TRACKS DO SHOW UP, 13,
- 8 14, AND 15, AND THE NUMBER LISTED IS 900,000, 700,000,
- 9 700,000. THOSE ARE CONSTRUCTION COSTS. SO WHEN WE ASK
- 10 WHERE THE NUMBERS COME FROM, LIKE WHERE IN HERE WOULD BE
- 11 THE ARCHITECT'S FEES?
- MR. CAYABYAB: THE WHAT NOW?
- 13 MR. HOCUTT: PARDON?
- 14 MS. RAHN: ARCHITECT FEES.
- 15 MR. HOCUTT: ARCHITECT'S FEES.
- 16 MR. CAYABYAB: ARCHITECT FEES. THAT'S JUST
- 17 CONSTRUCTION HARD COSTS.
- 18 MR. HOCUTT: I KNOW.
- MR. CAYABYAB: THE SOFT COST HAS ALREADY BEEN
- 20 APPROVED.
- MR. HOCUTT: BUT IT HASN'T BEEN SPENT YET. IT HAS TO
- 22 BE IN THE 126 MILLION. SO WHY WOULDN'T IT APPEAR ON THE
- 23 LIST OF EXPENSES THAT HAVE TO BE INCURRED? BECAUSE THESE
- 24 ARE DOWN HERE. THEY HAVEN'T BEEN DONE YET. SO IT'S
- 25 GETTING RIGHT BACK TO WHAT IS IN THE NUMBERS AND WHAT ISN'T

- 1 IN THE NUMBERS. IT LOOKS LIKE IT'S MISSING ARCHITECTURAL
- 2 FEES. AND WHILE I'M BEING PICKY, THE OTHER THING THAT IS
- 3 MISSING FROM THIS LIST IS THE FACILITIES ADMINISTRATION
- 4 COST. THAT'S NOT IN HERE. IT WAS IN THE PREVIOUS LIST,
- 5 BUT IT ISN'T IN THIS ONE.
- 6 MR. DEVEER: GLENN DEVEER.
- 7 I HAVE A QUESTION. I DON'T HAVE THAT DOCUMENT IN
- 8 FRONT OF ME, QUINCY, BUT LAST TIME WE LOOKED AT THE NEEDS
- 9 ASSESSMENT, WE CAME UP WITH A BALLPARK NUMBER JUST AMONGST
- 10 US HERE AROUND \$6 MILLION. IS THAT PART OF THAT?
- 11 MS. WANG: I THINK IT SHOULD BE.
- MR. DEVEER: IT SHOULD BE.
- 13 MR. HOCUTT: IT SHOULD BE. I DON'T KNOW. IT'S HARD
- 14 TO TELL WHAT'S IN IT.
- 15 MR. DEVEER: IF WE'RE CUTTING THIS THING CLOSE TO \$100
- 16 MILLION BUCKS FOR EIGHT PROJECTS, AND THERE'S A \$6 MILLION
- 17 FIGURE TO DO A NEEDS ASSESSMENT, MAYBE WE DON'T DO THE
- 18 NEEDS ASSESSMENT, BUT THAT'S THE BOARD'S DECISION. I DON'T
- 19 KNOW.
- MR. HOCUTT: BUT, AGAIN, THAT'S THE CENTRAL QUESTION
- 21 WE CAN'T ANSWER HERE, BUT WE NEED TO GET IT INTO OUR HEADS
- 22 THAT WE ARE RESPONSIBLE FOR TRANSPARENCY AND
- 23 ACCOUNTABILITY. SO THE QUESTION WHERE THE NUMBERS COME
- 24 FROM I THINK IS A LEGITIMATE QUESTION.
- 25 MR. CATES: SO, QUINCY, IF I UNDERSTAND YOU, YOUR

- 1 POINT IS THAT THE SPEND-OUT PLAN DOES NOT INCLUDE
- 2 EXPENDITURES THAT WILL HAVE TO BE MADE?
- 3 MR. HOCUTT: YES, THAT IS CORRECT.
- 4 MR. CATES: FOR EXAMPLE, ARCHITECTURAL FEES OR
- 5 PROPOSITION TT ADMINISTRATIVE FEES.
- 6 MS. RAHN: MIKALA RAHN. BUT THAT'S BACK TO MY POINT.
- 7 IF YOU HAD -- IF YOU HAD THE NUMBERS OF WHAT WE PLAN TO
- 8 SPEND, THEY MIGHT BE IN THAT. SO UNTIL WE -- RIGHT?
- 9 THAT'S WHY I DON'T AGREE THAT --
- 10 MS. KENNE: SOME OF THESE GO TOGETHER.
- MS. RAHN: EXACTLY. WE NEED THE FIRST BEFORE WE LOOK
- 12 AT THE SECOND.
- 13 MS. KENNE: EVEN IF WE HAVE THE CURRENT BUDGET AND
- 14 SOME OF THE NUMBERS ON THE NEW PRIORITY LIST ARE HIGHER, WE
- 15 CAN DROP THEM INTO THE EXISTING, AND SAY, NO, THAT'S BLOWS
- 16 UP EVERYTHING OR, OH, LOOK, IT ALL FITS. BUT, AGAIN, COME
- 17 BACK IN JUNE. TO BE CONTINUED.
- 18 MR. DEVEER: CLIFF, CAN I ADD SOMETHING HERE? YOU
- 19 KNOW, I WAS KIND OF PREPARED TO GO BACK TO III B II. WE
- 20 KIND OF BLEW BY THAT. I'M FINE WITH THAT BECAUSE WHAT I
- 21 WAS GOING TO DISCUSS WAS SOFT COSTS, AND THAT'S SMALL
- 22 POTATOES COMPARED TO THE OVERALL PICTURE THAT WE'VE BEEN
- 23 DISCUSSING HERE AS A GROUP.
- 24 BUT ONE OF MY FIRST QUESTIONS THAT I HAD HAD ON
- 25 MY LIST OF THINGS I WAS GOING TO TALK ABOUT WAS WHO

- 1 ESTABLISHES THE PROJECT BUDGET? AND IT'S REALLY UNKNOWN.
- 2 BECAUSE THE UNIT CONTRACTS MAKE DISCUSSION ABOUT MASTER
- 3 PROJECT BUDGET ESTABLISHED BY YOU, PUSD, AND I HAVE NO IDEA
- 4 WHERE THAT IS. I'VE NEVER SEEN IT.
- 5 IN FACT, THE ARCHITECTS DON'T EVEN SEE THIS WHEN
- 6 THEY BID ON THEIR PROJECTS. AND WHEN THE ARCHITECT IS
- 7 ASKED TO USE HIS PROFESSIONAL JUDGMENT TO DETERMINE THE
- 8 SCOPE OF WORK, DETERMINE THE SCOPE OF WORK, THAT'S WHAT
- 9 HE'S GOING TO DO. TWO CLASSROOMS, ONE AUDITORIUM,
- 10 WHATEVER. HE'S GOING TO DETERMINE THIS, AND THEN HE'S
- 11 GOING TO ESTABLISH THE COST TO FALL WITHIN THE ALLOTTED
- 12 FUNDS. AND THIS IS STRAIGHT OUT OF THE PROJECT AGREEMENTS
- 13 THAT YOU GUYS SIGNED WITH THESE FOLKS.
- 14 SO IT'S ALL FAIRLY LOOSEY-GOOSEY. AND IN TERMS
- 15 OF THE COST, JUST TO BANG ON THIS JUST A LITTLE BIT MORE
- 16 BECAUSE NORMA COOMBS WAS PROJECTED FOUR POINT SOME MILLION.
- 17 NOW WE'RE AT SIX POINT NINE.
- 18 ONE OF THE THINGS THAT THE ARCHITECT IS SUPPOSED
- 19 TO DO IS A SCHEMATIC. AND I TOOK IT RIGHT OUT OF THE
- 20 CONTRACT. I'LL READ IT VERBATIM HERE. WHERE IN THE HECK
- 21 IS IT?
- 22 DEVELOP A PRELIMINARY ESTIMATED COST FOR THE
- 23 PROJECT, ADD SCHEMATIC DESIGN AND DESIGN DEVELOPMENT.
- 24 WRITTEN. THAT'S ONE OF THE THINGS THAT I'VE ASKED FOR FROM
- 25 FACILITIES, AND WE HAVE NOT GOTTEN IT.

- 1 SO WHEN AN ARCHITECT GETS HIS PROGRAM WHICH HE
- 2 BASICALLY DEVELOPS. OH, NORMA COOMBS YOU KNOW WHAT THE
- 3 PROGRAM IS? THIS IS THE PROGRAM. THE SCOPE OF THE WORK.
- 4 RIGHT OUT OF THE CONTRACT. NORMA COOMBS ELEMENTARY SCHOOL
- 5 NEW CLASSROOM AND ADMINISTRATION BUILDING. PERIOD. THAT'S
- 6 IT. GIVE IT TO THE ARCHITECT AND -- LET ME FINISH -- AND
- 7 THEN HE'S GOING TO RUN WITH THIS. SO -- WHERE WAS I
- 8 HEADED? I'M SORRY. I LOST TRACK HERE.
- 9 THERE IS NO REAL OVERSIGHT FOR THESE ARCHITECTS.
- 10 WE'RE BUDGETED AT 4.2 MILLION. I IMAGINE THAT SOMEHOW HE
- 11 GOT THIS NUMBER FROM SOMEBODY, AND THEN SCHEMATIC -- WHEN
- 12 HE DOES HIS CONCEPT DESIGN, IT'S APPROVED BY PUSD. WITHOUT
- 13 AN APPROVAL HE DOES NOT GO TO SCHEMATICS. HE DOES THE
- 14 SCHEMATIC DESIGNS. IT'S APPROVED. HE DOES AN ESTIMATED
- 15 SCHEMATICS. IT'S APPROVED BY FACILITIES. IF FACILITIES
- 16 DOESN'T APPROVE IT, HE DOESN'T GO ON TO THE NEXT PHASE
- 17 WHICH IS DESIGN DEVELOPMENT. AGAIN, AT THE COMPLETION OF
- 18 DESIGN DEVELOPMENT, HE DOES AN ESTIMATE. IT'S APPROVED BY
- 19 FACILITIES BEFORE IT GOES INTO CONSTRUCTION DOCUMENTS.
- 20 CONSTRUCTION DOCUMENTS ON A SCHOOL SITE LIKE THIS
- 21 ON A \$4 MILLION PROJECT IS GOING TO RUN THREE, FOUR MONTHS.

- 24 HAVE APPROVED. THEN WHAT WE'RE HEARING IS THAT BETWEEN
- 25 WHEN DESIGN DEVELOPMENT WAS APPROVED AND ITS COMPLETION OF

- 1 CONSTRUCTION DOCUMENTS, THERE'S ALMOST A 2.3, 2.6 MILLION
- 2 DOLLAR ADD TO THE CONSTRUCTION COST? THAT MAKES NO SENSE.
- 3 WHY?
- 4 MR. CAYABYAB: ARE YOU DONE?
- 5 MR. DEVEER: YES.
- 6 MR. CAYABYAB: PERFECT EXAMPLE, MR. COLE, FOLLOWING
- 7 THAT PROCESS WITH BLAIR HIGH SCHOOL, WHAT DID STAFF FIND
- 8 BEFORE WE WERE EVEN READY TO GO OUT TO BID? HOW MUCH MONEY
- 9 WAS MISSING AND ALL THAT STUFF?
- 10 MR. COLE: FROM THE CONTRUCTABILITY REVIEW --
- 11 MR. CAYABYAB: YES.
- MR. COLE: -- AND EVERYTHING ELSE THAT CAME UP WITH,
- 13 ALMOST \$10 MILLION OF POTENTIAL CHANGE ORDERS.
- 14 MR. CAYABYAB: ERRORS AND OMISSIONS FROM THE ARCHITECT
- 15 FOLLOWING YOUR PROCESS. THAT'S WHY WE CAUGHT IT. THAT'S
- 16 ONE OF THE REASONS WHY. THERE IS A PERFECT OVERSIGHT ON
- 17 EACH ONE OF THESE STEPS. WE'RE DOING THAT NOW BEFORE WE
- 18 EVEN GO TO DSA AS PART OF THE CONSTRUCTABILITY REVIEW. WE
- 19 DON'T DEPEND ON ARCHITECTS JUST TO GIVE US A PROPOSAL TO DO
- 20 THIS BECAUSE WE'VE GOT A CLAIM AGAINST AN ARCHITECT NOW FOR
- 21 A PROJECT THAT WAS DONE FOR ERRORS AND OMISSIONS.
- 22 I INVITE YOU TO COME AND FOLLOW OUR PROCESS. WE
- 23 SIT DOWN BEFORE EVERY -- MR. COLE HAS BEEN INVOLVED WITH
- 24 THAT. WE'RE DOING THAT NOW FOR LONGFELLOW BEFORE IT GOES
- 25 OUT TO DSA. I WOULD RECOMMEND THAT YOU MAKE YOUR

- 1 RECOMMENDATION AND LOOK AT THE PROCESS BEFORE YOU COME TO
- 2 CONCLUSIONS THAT THERE'S A LACK OF OVERSIGHT FROM THE
- 3 STAFF. THIS IS NELSON CAYABYAB BY THE WAY.
- 4 MR. DEVEER: HOW DOES ERRORS AND OMISSIONS COME INTO
- 5 PLAY?
- 6 MS. RAHN: CAN I RECOMMEND THAT WE STICK TO THE
- 7 AGENDA? I MEAN, IT'S 8:20 AT NIGHT, GUYS.
- 8 MR. DEVEER: THAT WAS NO. D II.
- 9 MS. RAHN: ACTUALLY I THOUGHT YOU BROUGHT US BACK
- 10 TO ANOTHER ONE. YOU KNOW, WE'VE GOT TO FIGURE OUT HOW TO
- 11 MOVE THROUGH THESE AGENDAS.
- MR. DEVEER: GLENN DEVEER. I'M PERFECTLY FINE TO JUST
- 13 ZIP IT AND GO ON.
- 14 MR. CATES: WELL, LADIES AND GENTLEMEN, THERE'S
- 15 TENSION BETWEEN THE NEED TO COVER THESE ITEMS AND
- 16 EVERYONE'S DESIRE TO DO SO QUICKLY. SEVERAL MEETINGS AGO
- 17 WHEN I CRACKED THE WHIP OVER ONE MEMBER WHO WENT ON AND ON
- 18 WITH NON-GERMANE THINGS, THE DECISION OF THE COMMITTEE AT
- 19 THE NEXT MEETING WAS TO SPEND AS LONG AS IT TAKES. SO

- MS. RAHN: IT NEEDS TO BE REDUCED.
- 13 MR. CATES: I DON'T THINK I'VE EVER REJECTED ONE.
- 14 MS. RAHN: THAT MIGHT BE THE PROBLEM. IT'S TOO LONG.
- 15 MR. CATES: WELL, I'LL TELL YOU WHAT. WE'LL MOVE AS
- 16 EXPEDITIOUSLY AS POSSIBLE, AND THEN AT THE END YOU CAN TELL
- 17 ME WHICH ITEMS SHOULD NOT HAVE BEEN ON HERE.
- 18 MS. RAHN: I'LL JUST SEND YOU AN EMAIL.
- 19 MR. CATES: THAT'S FINE. BEARING IN MIND YOUR
- 20 REQUEST, LET'S TURN TO III E, STANDARDS FOR PROPOSITION
- 21 EXPENDITURES. THIS ITEM HAS BEEN PENDING FOR MONTHS NOW.
- 22 I RECENTLY RECEIVED FROM GLENN SOME VERY THOUGHTFUL,
- 23 SENSIBLE COMMENTS. I HAVE NOT HAD AN OPPORTUNITY TO REVISE
- 24 THE DRAFT STANDARDS.
- NOW, I CAN ASK GLENN TO EXPLAIN WHAT HIS

- 1 SUGGESTED CHANGES ARE, OR YOU CAN LET ME INCORPORATE THEM
- 2 INTO THE EXISTING DRAFT AND DISTRIBUTE IT FOR DISCUSSION AT

- 4 SO, MIKALA, IF YOU WISH TO DISCUSS THE SPECIFIC

- 1 MS. KENNE: IS THE GOAL TO BRING THEM BACK IN JUNE FOR
- 2 A VOTE?
- 3 MR. CATES: I HOPE SO. THAT'S BEEN THE GOAL FOR
- 4 SEVERAL MEETINGS NOW.
- 5 MS. KENNE: WELL, IF YOU PUT IT ON THE AGENDA FOR THE
- 6 VOTE, AT LEAST IT WILL BE THE INTENT TO VOTE.
- 7 MR. CATES: MY GUESS IS, KIM, THAT THERE WILL NOT BE
- 8 UNANIMOUS AGREEMENT ON THE TERMS.

- 18 THE ANALYSIS AND DRAFT RECOMMENDATIONS. TO EXPEDITE
- 19 MATTERS, I WOULD LIKE TO TAKE UP 1184 THROUGH 1193 AS A

- 9 MR. CAYABYAB: THESE ARE PROJECT MANAGER CONSULTANTS.
- 10 THEY'RE STILL APPLICABLE TODAY FOR EVERY SINGLE PROJECT.
- MS. WANG: YOU DON'T SEE CHANGES SINCE 2012?
- MR. CAYABYAB: NO, NONE AT ALL. THE DEMAND FOR THEIR
- 13 SERVICE IS STILL THERE. THIS IS NELSON CAYABYAB. JUST
- 14 REMEMBER WE'RE USING THESE FOLKS NOW, I'M USING THEM. I'VE
- 15 GOT THE PROPER STAFF TO MANAGE INSTEAD OF THE CONSTRUCTION
- 16 MANAGEMENT COMPANY WHICH IS GOING TO COST THE DISTRICT A

- 21 ABOUT HAVING PUSD STAFF, AND THESE CONTRACTS DON'T TELL ME

- MR. CATES: QUINCY?
- MR. HOCUTT: I HAVE A QUESTION ON 1192 AND 1193. EVEN
- 13 THOUGH IT WAS WRITTEN ON HERE THAT THESE ARE RENEWAL
- 14 CONTRACTS, IN REREADING, THEY APPEAR TO BE NEW. ARE THESE
- 15 NEW HIRES?
- 16 MR. CAYABYAB: THEY'RE TWO NEW HIRES. ONE OF THEM WAS
- 17 GOING TO BE HIRED ANYWAY AS A PROJECT INSPECTOR FOR THE
- 18 NORMA COOMBS PROJECT, BUT INSTEAD I TOOK THE LIBERTY OF
- 19 HIRING BACK AS A PROJECT MANAGER SOMEONE WHO WORKS FOR THE
- 20 DISTRICT; SO I CAN UTILIZE THE INDIVIDUAL NOT ONLY FOR
- 21 NORMA COOMBS BUT OTHER PROJECTS THAT ARE COMING UP, SMALLER
- 22 PROJECTS.
- MR. HOCUTT: WHO IS THE OTHER GENTLEMAN?
- MR. CAYABYAB: THE OTHER GENTLEMAN IS A SUPERINTENDENT
- 25 POSITION, AND THAT RESPONSIBILITY OF THE SUPERINTENDENT

- 1 POSITION IS TO ASSIST PROJECTS AND MAKING SURE THAT WE MEET
- 2 THE CRITICAL MILESTONES ON THE SCHEDULE. THAT INDIVIDUAL
- 3 WILL CHECK ON WHETHER PARTS ARE ORDERED ON TIME, PROPERLY,
- 4 AND THAT INDIVIDUAL WILL ALSO START COORDINATING THE TRADES
- 5 AND SO TO MAKE SURE THE ELECTRICAL MEETS WITH THE GENERAL

- 13 MR. CATES: DOES EVERYONE WANT TO VOTE ON THE
- 14 RECOMMENDED APPROVAL OF THE BOARD REPORTS INDIVIDUALLY OR
- 15 CAN WE DO THEM AS A GROUP?
- MR. COLE: AS A BLOCK.
- 17 MR. CATES: SO I MOVE THAT THE COMMITTEE APPROVE THE
- 18 EXPENDITURES DESCRIBED IN BOARD REPORTS 1184 THROUGH 1193.
- 19 MR. COLE: I'LL SECOND.
- 20 MR. CATES: ALL IN FAVOR? OPPOSED?
- MR. DEVEER: OPPOSED.
- MR. CATES: ABSTAINED?
- MR. DEVEER: NO.
- MR. CATES: OKAY. SO THAT'S 8 TO 1.
- OKAY. BOARD REPORTS 1180 THROUGH 1183 DO NOT

- 1 PERTAIN TO MEASURE TT SO I'M NOT GOING TO ASK THE COMMITTEE
- 2 TO PASS ON THEM WHICH LEAVES US WITH BOARD REPORT 114-B
- 3 WHICH IS THE ONE FOR WHICH DISAPPROVAL IS RECOMMENDED.
- 4 YOU HAVE THE BOARD REPORT IN FRONT OF YOU. IT IS
- 5 FOR AN ADDITIONAL 200,000 FOR LEGAL FEES, AND THE
- 6 DESCRIPTION IS FOR LEGAL SERVICES THROUGH JUNE 30, 2017.
- 7 SERVICES INCLUDE REPRESENTATION FOR GENERAL AND
- 8 CONSTRUCTION LEGAL SERVICES AS WELL AS PROVIDING THE
- 9 DISTRICT WITH INFORMATIVE NEWSLETTERS, TRAINING
- 10 OPPORTUNITIES, AND CONFERENCES TO HELP THE DISTRICT WITH
- 11 DAILY LEGAL CONCERNS. MANY OF THOSE ITEMS ARE
- 12 ADMINISTRATIVE COSTS WHICH THE LAW DOES NOT ALLOW TO BE
