8	I DON'T SEE ANY MEMBER OF THE PUBLIC SO WE'LL	
9	MOVE ON TO PENDING BUSINESS.	
10	THE FIRST ITEM IS WHETHER OR NOT WE REPLACE OUR	
11	MEETING MINUTES WITH THE EXISTING VERBATIM TRANSCRIPTS. WE	
12	DISCUSSED THIS AT OUR LAST MEETING, DECIDED TO DEFER ANY	
13	DECISION UNTIL THIS MEETING, AND QUINCY HAS SENT OUT TO ALL	
14	OF YOU A LIST OF PROS AND CONS WHICH I WOULD APPRECIATE	
15	YOUR SUMMARZING, QUINCY.	
16	MR. HOCUTT: THE PROS WERE THAT THE TRANSCRIPT COVERS	
17	ALL THE DISCUSSION AND ALL POINTS. IT'S ANALOGOUS TO THE	
18	DEO THAT THE BOARD OF EDUCATION PRODUCES. IT COULD	
19	PROVIDE NO NEED TO PRODUCE A SUMMARY SET OF THE MINUTES	
20	THAT WE'VE BEEN DOING, AND IT DOES SAVE TIME OF STAFF AND	
21	COC MEMBERS TO WRITE AND REVIEW THE MINUTES. SO THOSE ARE	
22	THE PROS.	
23	THE CONS ARE IT IS A LENGTHY DOCUMENT, IN MOST	
24	CASES OVER 120 PAGES, WHICH I THINK REDUCES THE PROBABILITY

- 3 POINTS; THE TRANSCRIPT IS JUST CONTINUOUS. EQUAL WEIGHT IS
- 4 GIVEN TO ANY DISCUSSION, ANY ISSUE, ANY COMMENT. IT
- 5 ACTUALLY IN MY OPINIONS REDUCES THE TRANSPARENCY OF WHAT
- 6 ACTUALLY OCCURRED IN THE COC MINUTES BECAUSE IT'S JUST SO
- 7 VOLUMINOUS. THAT'S PRETTY MUCH IT.
- 8 MR. CATES: I WOULD ADD TO ADD ONE OTHER THING. TO
- 9 PRODUCE DECENT MINUTES TAKES AN INORDINATE AMOUNT OF TIME,
- 10 ALMOST ALL OF WHICH HAS BEEN SPENT BY QUINCY AND MIGUEL,
- 11 BUT ON THE COMMITTEE, QUINCY, WHO HAS OTHER THINGS TO DO.
- 12 I PERSONALLY WOULD LIKE TO SEE US CONTINUE WITH
- 13 MINUTES BECAUSE THEY'RE A LOT EASIER TO FOLLOW THAN THE
- 14 TRANSCRIPT AS QUINCY JUST SAID. BUT NOT AT ANY COST. AND
- 15 RIGHT NOW I THINK THE COST IS TOO HIGH. IT TAKES TO LONG
- 16 TO PRODUCE THEM. AND THE TRANSCRIPT, HOWEVER DISJOINTED,
- 17 INARTICULATE, UNGRAMMATICAL, YOU NAME IT, IS PRODUCED BY
- 18 SOMEBODY ELSE. OUR FRIENDLY REPORTER.
- 19 DISCUSSION?
- 20 MR. PEREZ: I HAVE A SMALL COMMENT. QUINCY JUST
- 21 MENTIONED THAT IT WAS DIFFICULT TO FIND THE DIFFERENT
- 22 ITEMS, AND THESE TRANSCRIPTS ARE PRODUCED IN PDF, AND I
- 23 COULD -- I COULD ADD BOOKMARKS TO EVERY ITEM SO YOU COULD
- 24 SEE ITEM I-A, II-B AND II-IC AS LONG AS THE CHAIR TRIES TO
- 25 IDENTIFY CLEARLY AND WE FOLLOW THAT ORDER. BECAUSE

- 1 SOMETIMES AT MEETINGS WE JUMP FROM III-A TO IV-B OR
- 2 WHATEVER. BUT I WAS READING THE LAST DECEMBER TRANSCRIPT,
- 3 AND, YOU KNOW, I DIDN'T KNOW IF I WAS GOING TO PREPARE THE
- 4 MINUTES, BUT, ANYWAY, I USUALLY FOR MY OWN USE I INCLUDE
- 5 BOOKMARKS, SO IT'S QUITE EASY TO JUMP TO THE BOOKMARKS AND

- 14 THE MINUTES WITH THE VERBATIM TRANSCRIPT, BUT TO BE HONEST,
- 15 I'M HAPPY WITH BOTH IF YOU WANT BOTH BECAUSE I THINK THAT
- 16 YOUR PROS OF EASE OF READING IS A GOOD POINT. MY CONCERN
- 17 WAS THE EDITORIALIZING, BUT IT'S NOT AS MUCH A CONCERN
- 18 THESE DAYS, AND THE VERBATIM TRANSCRIPT IS THERE FOR
- 19 ANYBODY TO READ. I DO BELIEVE THAT ANYBODY THAT TAKES THE
- 20 TIME TO GET TO THAT POINT IS GOING TO READ BOTH BECAUSE IT
- 21 TAKES A LITTLE BIT OF WORK TO GET THERE. THEY'RE NOT GOING
- 22 TO EXPEND THAT EFFORT AND SAY IT'S TOO MUCH. I THINK
- 23 THEY'RE GOING TO READ BOTH, OR THEY'RE GOING TO READ EITHER
- 24 IF EITHER IS THERE. I THINK REPLACING IT WITH THE VERBATIM
- 25 TRANSCRIPT IS A BETTER WAY TO GO BECAUSE IT'S EASIER. I

- 1 DON'T HAVE A BIG OBJECTION IF YOU WANT TO HAVE BOTH.
- 2 MS. VANCE: I WOULD SAY IF THERE'S ANY WAY FOR US TO
- 3 NOT WORK AS HARD ON THE MINUTES, LIKE TO MAKE THEM NOT AS
- 4 DETAILED SO THAT YOU DON'T HAVE TO SPEND AS MUCH TIME, AND
- 5 THEN NOTATE THE PAGE NUMBER ON THE PDF WHERE THEY CAN
- 6 REFERENCE. SO WITHIN THE MINUTES NOTATE THE PAGE OF THE
- 7 PDF OF THE TRANSCRIPT SO THAT YOU DO HAVE MINUTES THAT ARE
- 8 NOT AS DETAILED, AS YOU'VE DONE IN THE PAST, SO THAT IT
- 9 DOESN'T TAKE YOU AS MUCH TIME, BUT MAYBE HAVE STAFF AT PUSD
- 10 NOTATE THE PAGE NUMBER WHERE IF SOMEBODY WANTS TO DIG
- 11 DEEPER INTO THAT PARTICULAR ITEM, THEY CAN JUST GO TO THE
- 12 VERBATIM TRANSCRIPT AND LOOK AT THAT PAGE NUMBER. THAT WAY
- 13 YOU DO HAVE A SYNOPSIS, A SHORT OVERVIEW OF WHAT WAS
- 14 DISCUSSED AT THE MEETING AND THE VOTES MOSTLY -- WHAT I
- 15 THINK IS MOST IMPORTANT -- THIS PASSED FIVE TO FOUR OR
- 16 UNANIMOUSLY OR WHATEVER, AND THEN IF IT DIDN'T OR SOMEBODY
- 17 WANTS TO LOOK DEEPER INTO THAT PARTICULAR ITEM, THEY COULD
- 18 GO BACK IN TRANSCRIPT AND EASILY READ WHETHER IT BE VIA
- 19 BOOKMARK OR PAGE NUMBER. I WOULD SAY PAGE NUMBER. THAT
- 20 WOULD BE EASIER. BUT, FRANKLY, I DON'T WANT -- I WOULD
- 21 RATHER HAVE MINUTES THAN THE VERBATIM TRANSCRIPT.
- 22 MR. CATES: GRETCHEN, WE'RE GOING TO HAVE A VERBATIM
- 23 TRANSCRIPT ONE WAY OR THE OTHER. THE QUESTION IS WHETHER
- 24 OR NOT WE HAVE MINUTES IN ADDITION TO THE TRANSCRIPT, AND,
- 25 IF SO, WHAT KIND OF MINUTES, AND YOU'VE SUGGESTED MORE OF

- 1 AN OUTLINE FORM OF MINUTES WITH REFERENCES TO THE
- 2 TRANSCRIPT.
- 3 QUINCY, WHAT DO YOU THINK OF THAT?
- 4 MR. HOCUTT: I THINK THAT WOULD BE USEFUL.
- 5 MR. BOLAND: ACTUALLY, IT'S A GOOD COMBINATION OF THE
- 6 TWO.
- 7 MR. HOCUTT: AND I DO WANT TO MAKE A COMMENT. EVEN I
- 8 HAVE NOT READ -- FORGIVE ME -- ALL OF THE LAST VERBATIM
- 9 TRANSCRIPT BECAUSE I DECIDED I WASN'T GOING TO DO MINUTES
- 10 UNTIL WE HAD THIS DISCUSSION SO I LOOKED THROUGH THE LAST

- 24 READING ALL OF THIS, IT WAS SO LEGALIZED I THOUGHT, OKAY,

- 18 HAVE DONE OTHERS IS AT THE END OF EACH ITEM THE CHAIR
- 19 SUMMARIZES. SAY, FOR INSTANCE, REPLACEMENT OF MINUTES, AND

- 4 MEAN, I KNOW HOW TO LISTEN, AND I KNOW HOW TO SUMMARIZE.
- 5 IS THAT WHAT YOU WANT?
- 6 YOU STILL HAVE THE VERBATIM TRANSCRIPT AS A
- 7 PROTECTION, BUT AFTER, LET'S SAY, A DETAILED DISCUSSION,
- 8 I'M NOT SURE THAT IT'S A GOOD IDEA TO HAVE THE MINUTES
- 9 REFLECT MY SUMMARY.
- 10 MR. PEREZ: THAT SUMMARY IS APPROVED BY THE ATTENDEES.
- 11 MR. CATES: I KNOW, BUT I CAN USE MY SKILLS IN EDITING
- 12 AND SELECTING AND THEN ASKING PEOPLE DO YOU APPROVE IT OR
- 13 NOT.
- 14 MS. VANCE: I DON'T EVEN THINK IT'S A BAD IDEA TO SAY
- 15 DETAILED DISCUSSION ENSUED OR SOMETHING. SEE PAGE BLAH,
- 16 BLAH, BLAH. BECAUSE THEN IF SOMEBODY WANTS TO GO DEEPER
- 17 INTO THE DISCUSSION, THEY CAN EASILY REFERENCE IT.
- 18 MR. HOCUTT: SO AT THIS POINT SHOULD WE CALL FOR A
- 19 VOTE OF CONTINUING THE MINUTES?
- 20 MR. CATES: HERE'S MY SUGGESTION. THAT WE CONTINUE
- 21 FOR AS LONG AS WE THINK NECESSARY THE MINUTES, INCLUDING
- 22 PRODUCTION OF THE MINUTES FOR THE NOVEMBER AND DECEMBER
- 23 MEETINGS BUT IN DIFFERENT FORMAT, MORE ALONG THE LINES OF
- 24 WHAT GRETCHEN HAS SUGGESTED WHICH IS OUTLINE FORMAT
- 25 BASICALLY WITH PAGE REFERENCES TO THE TRANSCRIPT, AND

- 1 PERHAPS A SUMMARY BY THE CHAIR OF THE DISCUSSION. THAT'S
- 2 MY SUGGESTION, BUT I DO NOT HAVE STRONG FEELINGS ON THIS
- 3 MATTER.
- 4 MS. VANCE: I JUST DON'T WANT QUINCY TO HAVE TO PUT IN
- 5 A WHOLE BUNCH OF TIME. I KNOW IT'S NOT WORTH IT, AND I
- 6 WISH I COULD SAY I COULD HELP YOU, BUT I DON'T EVEN HAVE
- 7 ENOUGH TIME TO DO OTHER THINGS SO THERE'S NO WAY I CAN
- 8 AGREE TO HELP YOU.
- 9 MR. CATES: IS ANYONE ELSE WILLING TO HELP QUINCY?
- 10 MS. VANCE: ISN'T JEN HELPING YOU?
- MR. HOCUTT: THEY REVIEW WHAT WE PUT OUT.
- MR. BOLAND: IF YOU END UP GETTING STUCK WITH IT, I'LL
- 13 HELP YOU OUT, BUT IT WOULD BE KIND OF IRONIC BECAUSE I
- 14 DON'T THINK YOU WANT MY HELP, BUT I DON'T HAVE STRONG
- 15 FEELINGS EITHER.
- 16 MR. HOCUTT: WOULD YOU LIKE TO VOLUNTEER TO BE ON THE
- 17 MINUTES SUBCOMMITTEE?
- 18 MR. BOLAND: I WOULD RATHER NOT, BUT I WILL HELP YOU
- 19 IF YOU GET STUCK.
- MS. VERDUGO: I WILL TOO.
- MR. CATES: DO WE NEED A VOTE ON THIS?
- MR. HOCUTT: I THINK SO.
- MR. CATES: IS THERE ANY FURTHER DISCUSSION? I WILL
- 24 ENTERTAIN A MOTION OR TWO OR THREE.

- 1 MR. HOCUTT: WELL, THERE HAS TO BE A MOTION.
- 2 MS. VANCE: SORRY.

- 3 MR. PEREZ: EXCUSE ME. I WOULD LIKE TO MAKE A COMMENT
- 4 IN REGARD TO THE NORMA COOMBS.
- 5 MR. CATES: ALL RIGHT.
- 6 MR. PEREZ: AT ONE OF THE LAST MEETINGS I EXPLAINED
- 7 HOW THE NORMA COOMBS BUDGET WAS DEVELOPED, AND I THINK IT
- 8 WAS IN 2008, AND THEN HOW IT WAS CHANGED. OKAY? AT ONE OF
- 9 THE MEETINGS GLENN SPECIFICALLY ASK FOR INFORMATION, FULL
- 10 DISCLOSURE OF THE INFORMATION OF THE NORMA COOMBS PROJECT,
- 11 AND I HAVE -- I HAD PREPARED THIS -- THIS IS A FLASHDRIVE,
- 12 AND I WANTED TO GIVE IT TO GLENN AT THE DECEMBER MEETING,
- 13 BUT HE DIDN'T COME, AND I WILL GIVE IT TO YOU. HERE'S A
- 14 COPY OF THE LETTER. HERE IS THE PEN DRIVE, AND HERE'S THE
- 15 DETAILED LIST OF ITS CONTENTS, AND THIS HAS ALREADY BEEN
- 16 PUBLISHED. I SHOULD HAVE A COPY OF THAT LATER. YOU CAN
- 17 GIVE IT BACK TO ME.
- 18 SO IN REGARD TO NORMA COOMBS, LET'S SAY FOR THE
- 19 RECORD, LET'S NOTE THAT THE INFORMATION WAS PROVIDED. I
- 20 DON'T KNOW IF IT WILL SATISFY.
- MR. CATES: I WILL ACKNOWLEDGE THAT I JUST RECEIVED A
- 22 FLASHDRIVE. I HAVE NO IDEA, OF COURSE, WHAT'S ON IT. I
- 23 HAVE NO IDEA TO WHAT EXTENT THE INFORMATION CONTAINED ON
- 24 THE FLASHDRIVE IS RESPONSIVE.
- 25 MR. PEREZ: IT'S ALL IN THE LETTER.

- 1 MR. HOCUTT: IS THAT THE SAME DATA THAT YOU SENT OUT
- 2 TO THE COC BEFORE WE ACTUALLY GOT THIS LETTER?
- 3 MY VIEW OF THAT -- RIGHT OR WRONG -- IS THAT I
- 4 ACTUALLY READ THROUGH THE 9,000 PAGES THAT'S ON THE
- 5 FLASHDRIVE -- I'M EXAGGERATING -- I SAW NO EXPLANATION
- 6 THERE, NONE, OF HOW THE BUDGET FOR NORMA COOMBS WAS
- 7 DETERMINED. I THEN SENT AN EMAIL TO GLENN SAYING, "GLENN,
- 8 WE RECEIVED THIS DATA. DO YOU SEE AN EXPLANATION THERE OF
- 9 HOW THE BUDGET WAS DERIVED?" HIS REPLY BACK TO ME WAS HE
- 10 DOES NOT. SO WE WOULD STILL CONTEND THAT -- WE DON'T NEED,
- 11 I THINK, A LENGTHY EXPLANATION OF HOW PUSD COMES UP WITH A
- 12 BUDGET, BUT I THINK IT WOULD BE INSTRUCTIVE FOR ALL OF US,
- 13 SINCE BUDGETS ARE IMPORTANT, TO HAVE SOME FEEL FOR HOW

- 16 DOCUMENTS LIKE HOW TO BURY A POST IN CEMENT. THAT DOESN'T
- 17 ANSWER THE OUESTION.
- 18 MR. PEREZ: OKAY. I WILL TRY TO GIVE YOU A BRIEF
- 19 DESCRIPTION. IN THE LAST --
- MR. HOCUTT: BEFORE YOU DO, LET ME MAKE A PROPOSAL AND
- 21 SEE IF THIS IS GOOD. WOULD IT BE OUT OF LINE TO ASK THE
- 22 PUSD STAFF -- AND BY THAT I MEAN NELSON -- TO PREPARE A
- 23 RESPONSE FOR III-B, PUTTING IT INTO THREE SEPARATE SECTIONS
- 24 AND ANSWERING THE REQUESTS FOR INFORMATION? WE'VE ASKED
- 25 HOW YOU'RE GOING TO ALLOCATE THE LEGAL FEES. ARE YOU GOING

- 1 TO BACK ANY OF THE ERRONEOUS ONES OUT? HOW WERE THEY
- 2 DETERMINED? THAT WOULD BE ONE QUESTION TO ANSWER. WHERE
- 3 ARE YOU? WHAT ARE YOU DOING ABOUT IT? WHAT'S YOUR
- 4 POSITION ON IT? NUMBER TWO WOULD BE WHAT ARE YOU GOING TO
- 5 DO WITH THE STAFF SALARIES THAT THIS COMMITTEE HAS
- 6 DETERMINED ARE NOT LEGAL TO BE CHARGED TO TT? WHAT ARE YOU
- 7 GOING TO DO ABOUT THAT? OR DO YOU AGREE WITH OUR POSITION?
- 8 AND, THREE, HOW DO YOU ESTABLISH A BUDGET FOR ANY
- 9 PARTICULAR SCHOOL PROJECT? ANSWER THOSE THREE SIMPLE
- 10 QUESTIONS IN A PRESENTATION TO THE COC.
- MR. PEREZ: IF I MAY, NORMALLY THE LAST PART, HOW WE
- 12 ESTABLISH A BUDGET -- OKAY? -- THERE WAS A MASTER PLAN WITH
- 13 CERTAIN AMOUNTS FOR EACH SCHOOL, AND THEN THERE WAS AN
- 14 ORDER TO REDUCE EVERY PROJECT I GUESS IT WAS 20 PERCENT?
- 15 MS. VANCE: YEAH, IT WAS 20 PERCENT. SO THE MASTER
- 16 PLAN CAME OUT IN 2008, AND IN 2012 THEY CUT EVERYTHING
- 17 ACROSS THE BOARD.
- 18 MR. PEREZ: ACROSS THE BOARD. DOESN'T MATTER HOW MUCH
- 19 IT SAID. 5 MILLION? NOW YOU HAVE 4 MILLION. AND SINCE
- 20 THAT, TIME HAS ELAPSED, AND THE STAFF HAS PREPARED
- 21 ESTIMATES FOR THAT SAME PROJECT. IN THE CASE OF NORMA
- 22 COOMBS, THE STAFF MADE AN ESTIMATE ABOUT SIX-MILLION
- 23 SOMETHING, AND IT WENT OUT TO BID.
- MR. HOCUTT: THAT'S THE QUESTION. HOW DID THEY
- 25 ESTIMATE IT? WHAT IS IT BASED ON?

- 1 MR. PEREZ: WE ACTUALIZE THE COSTS. I'M NOT SURE IF
- 2 THE DISTRICT USES IT, BUT THERE IS A BOOK, VERY STANDARD
- 3 USE. IT'S CALLED "RSMEANS," AND THAT PROVIDES UNITARY
- 4 COSTS FOR ALL OR ALMOST ALL THE CONSTRUCTION ACTIVITIES IN
- 5 THE UNITED STATES. HOW DO THEY COME TO THAT? IT'S DIVIDED
- 6 IN LABOR, MATERIAL, AND EQUIPMENT, AND THEY HAVE FACTORS.
- 7 FOR INSTANCE, THE FACTOR FOR EQUIPMENT IN CALIFORNIA IS
- 8 3.1. MAYBE IN TEXAS IT'S 3.4. OKAY? THAT'S THEIR
- 9 BUSINESS. AND WHEN I WORK ESTIMATING, THAT'S WHAT WE DID.
- 10 WE USE THAT, AND WE FOUND OUT, FOR INSTANCE, THE PRICE OF
- 11 CONCRETE HOW MUCH WAS IT IN 2012 AND HOW MUCH WAS IT AT THE
- 12 END OF 2016 OR '17. SO THAT'S HOW THESE CHANGES COME TO
- 13 BE, AND I ALSO BELIEVE THAT THE ARCHITECTS THEY PROVIDE AN
- 14 ESTIMATE.
- 15 MR. HOCUTT: WE THINK THAT THAT'S THE ANSWER. THAT
- 16 THE ESTIMATE COMES FROM THE ARCHITECTS.
- 17 MR. PEREZ: YES. BUT ALSO OUR PROJECT MANAGERS THEY
- 18 HAVE A SAY IN THAT BECAUSE THERE'S NOT ALWAYS THE NUMBERS
- 19 THAT THE ARCHITECT PROVIDES, BUT OUR PROJECT MANAGERS ALSO
- 20 THEY HAVE MORE KNOWLEDGE OR DIVERSE KNOWLEDGE BECAUSE THEY
- 21 ARE IN THE FIELD ON DIFFERENT PROJECTS, AND THEY KNOW HOW
- 22 MUCH THINGS ARE GOING TO COST. OF COURSE THESE ARE
- 23 ESTIMATES. HOW MUCH IT'S GOING TO COST? WELL, AT THE END
- 24 WHEN WE RECEIVE THE BID 6.4, 6.5, 6.7, THAT'S HOW MUCH IT'S
- 25 GOING TO COST. AND IN THE ECONOMIC ENVIRONMENT WE'RE

- 1 LIVING IN, THIS IS GOING TO INCREASE -- I SEND YOU, BOTH OF
- 2 YOU THERE'S GOING TO BE A SEMINAR ORGANIZED BY CASH. IT'S
- 3 COALITION FOR SCHOOL DEVELOPMENT, OR SOMETHING LIKE THAT.
- 4 ONE OF THE POINTS WAS HOW TO ADDRESS THE CHANGES IN THE
- 5 COST OF THE UPCOMING FUTURE DUE TO A DIFFERENT FACTOR THAT
- 6 ARE IMPACTING OUR ECONOMY. SO THAT'S SOMETHING THAT IS
- 7 COMMON. WE HAVE BEEN -- AT THE LAST MEETING YOU TALK ABOUT
- 8 THE BOND, AND OF COURSE MONEY IN 2018 JANUARY, MONEY WILL
- 9 NOT BUY THE SAME FOUR YEARS FROM NOW. SO THAT'S HOW
- 10 BUDGETS CHANGE.
- 11 AND THE OTHER PART IS THAT BUDGETS ARE IMPACTED
- 12 BY CHANGE ORDERS. THAT'S A DIFFICULT ITEM, BUT THIS
- 13 AFTERNOON I WAS TALKING WITH ONE OF THE PROJECT MANAGERS,
- 14 AND HE SAID IT TO ME VERY SIMPLE. LISTEN, CHANGE ORDERS IS
- 15 SOMETHING THAT HAS TO BE DONE. IT WASN'T SEEN ORIGINALLY.
- 16 IT DOESN'T MATTER BECAUSE ANYHOW IT HAS TO BE DONE. IF IT
- 17 WAS DETECTED PRIOR, YOU WOULD KNOW AHEAD. BUT, ANYHOW,
- 18 IT'S SOMETHING THAT YOU HAVE TO PAY FOR. EVEN YOU MIGHT
- 19 KNOW EARLIER OR LATER, BUT IF YOU FORGET A LADDER FOR THE
- 20 SECOND FLOOR, YOU WILL NEED IT.
- 21 MR. HOCUTT: THAT'S A DIFFERENT SUBJECT THAT I WANT TO
- 22 TALK ABOUT IN THE BOARD REPORTS.
- MR. PEREZ: YES. BUT THAT'S HOW THE BUDGET EVOLVES.
- MR. CATES: WITH RESPECT, WE DIDN'T ASK HOW DOES A
- 25 BUDGET EVOLVE. WE SAID WHAT WAS THE BASIS FOR THE BUDGET

- 1 AS IT EXISTED IN MAY OF 2017.
- 2 MR. BOLAND: CAN I SUMMARIZE WHAT I JUST HEARD THERE?
- 3 YOU'RE TELLING US THAT YOU HAVE A BOOK OF STANDARDIZED
- 4 CONSTRUCTION COSTS WITH WHICH YOU CARVE OUT A NUMBER FOR A
- 5 PROJECT, AND THEN YOU'RE SAYING THAT NUMBER GETS CARVED
- 6 DOWN BY THE ARCHITECT PLANNING AND THEN FURTHER BY THE
- 7 IN-FIELD EXPERIENCE OF THE PEOPLE ACTUALLY DOING IT; RIGHT?
- 8 MR. PEREZ: LET ME QUOTE. I'M NOT SURE IF THE
- 9 DISTRICT HAS THE "RSMEANS" BOOK, BUT THAT'S THE WAY THE
- 10 INDUSTRY WORKS IN MANY AREAS.
- 11 MR. BOLAND: IT'S CONCERNING BECAUSE YOU'RE KIND OF
- 12 GIVING US A GENERAL IDEA OF HOW YOU GET TO IT, BUT AT NO
- 13 POINT DOES IT SOUND LIKE THERE WAS AN AGREEMENT ON COSTS
- 14 AHEAD OF TIME. YOU KNOW WHAT I MEAN? IT SOUNDS LIKE WE
- 15 CARVED OUT A LUMP OF CLAY, AND NOW WE'RE GOING TO WORK ON
- 16 IT AS WE WORK ON THIS, AND AT THE END WE'LL TELL YOU WHAT
- 17 IT COSTS. THAT'S NOT GOING TO MATCH UP WITH WHAT HE'S
- 18 ASKING FOR. HE'S LOOKING FOR A SET OF NUMBERS AHEAD OF
- 19 TIME THAT MATCH UP WITH THE NUMBERS AT THE END. I GET WHAT
- 20 YOU'RE SAYING. WHEN YOU SIT AROUND FOR FOUR YEARS NOT
- 21 DOING ANYTHING, PRICES CHANGE.
- 22 MR. PEREZ: DSA ALSO MAKES MODIFICATIONS. ONE OF THE
- 23 ITEMS WE'RE GOING TO DEAL WITH TODAY --
- MR. BOLAND: IT SEEMS TO ME THERE NEEDS TO BE A FIRMER
- 25 PROCESS FOR DEVELOPING BUDGETS. I AGREE WITH WHAT HE'S

- 1 SAYING. IF THERE WAS A FIRMER PROCESS FOR WHAT YOU
- 2 EXPECTED AT THE END ESTABLISHED AT THE BEGINNING. IT'S
- 3 JUST ALL A MYSTERY UNTIL YOU GET TO THE END.
- 4 MS. VANCE: WHAT WAS THE NORMA COOMBS NUMBERS IN 2012?
- 5 MR. BOLAND: WAS I CORRECT IN MY SUMMARY?
- 6 MR. CATES: YES.
- 7 MR. PEREZ: IT WAS FOUR POINT SOMETHING.
- 8 MS. VANCE: WHAT IS THE CURRENT SPEND ON NORMA COOMBS?
- 9 MR. PEREZ: IT'S GOING TO BE 6.4. THAT'S THE BID.
- 10 MS. VANCE: IS THAT THE ISSUE THAT YOU'RE ASKING
- 11 BECAUSE IT'S SO OVER --
- MR. CATES: GRETCHEN, WE CHOSE NORMA COOMBS AS A TEST
- 13 CASE. HOW WAS THE BUDGET NUMBER ARRIVED AT.
- 14 MS. VANCE: OKAY.
- 15 MR. HOCUTT: THE REAL QUESTION IS HOW DO YOU GET ANY
- 16 BUDGET NUMBER THAT'S ON THE BUDGET SHEET FOR ANY SCHOOLS,
- 17 ANY PROJECT? HOW IS IT DONE?
- 18 MS. VANCE: THAT REALLY HAS NOTHING TO DO WITH HIM.
- 19 THAT HAS TO DO WITH THE SCHOOL BOARD NOT UPDATING THEIR
- 20 FACILITIES MASTER PLAN. THEY'RE JUST SPENDING MONEY.
- MR. CATES: BUT THE SCHOOL BOARD DOESN'T ACTUALLY
- 22 PREPARE THE BUDGET FOR A PROJECT. THE DISTRICT PREPARES
- 23 IT, AND THE SCHOOL BOARD APPROVES IT OR DISAPPROVES IT OR
- 24 CHANGES IT.
- 25 MS. VANCE: RIGHT. BUT THE PROBLEM IS IS THE LAST

- 1 TIME THEY PREPARED BUDGETS FOR THE FACILITIES MASTER PLAN
- 2 WAS IN 2008, AND THEN THEY DID CUT ACROSS THE BOARD OF 20
- 3 PERCENT IN 2012, AND NOBODY HAS EVER PREPARED UPDATED
- 4 BUDGETS.
- 5 MR. CATES: BUT WE ASKED ABOUT A SPECIFIC NORMA COOMBS
- 6 BUDGET. USING IT AS A TEST CASE, HOW DID YOU COME UP WITH
- 7 THIS NUMBER.
- 8 MR. HOCUTT: WE'RE NOT CHALLENGING IT. WE'RE NOT
- 9 GOING TO SIT HERE AND CRITIQUE WHETHER IT'S RIGHT OR WRONG.
- 10 BUT I THINK FOR A COMMITTEE LIKE THIS IT'S APPROPRIATE TO
- 11 ASK HOW DO YOU COME UP WITH A BUDGET? WHAT IS THE PROCESS?
- MR. BOLAND: HE DOESN'T KNOW.
- 13 MS. VANCE: DON'T YOU THINK THAT NELSON WOULD SAY THAT
- 14 THEY SEND OUT -- WHAT ARE THEY CALLED? -- SOMETHING
- 15 STUDIES. THEY DO FEASIBILITY STUDIES. AREN'T WE PAYING
- 16 CURRENTLY FOR AN OUTSIDE CONSULTANT TO DO FEASIBILITY
- 17 STUDIES ON NEW CONSTRUCTION THAT THEY'RE HOPING TO GET PAID
- 18 FOR WITH ANOTHER BOND?
- MR. HOCUTT: WE'RE PAYING A LOT OF MONEY FOR NEEDS
- 20 ANALYSIS.
- MS. VANCE: NEEDS ANALYSIS. THAT'S WHAT IT'S CALLED.
- 22 MR. HOCUTT: WHICH, BY THE WAY, WE'LL TALK ABOUT WHEN
- 23 WE GET TO BOARD REPORTS BECAUSE THOSE DON'T CUT IT EITHER.
- MS. VANCE: I'M ASSUMING THAT THOSE NEEDS ANALYSIS ARE
- 25 PART OF THE BUDGETING?

- 1 MR. PEREZ: THOSE ARE ONE OF THE ELEMENTS THAT ARE
- 2 USED TO IDENTIFY THE TOTAL COSTS. THE ARCHITECTS ALSO
- 3 PROVIDE AN ESTIMATE. OKAY? SO, ANYWAY, WHAT YOU WANT,
- 4 SEND THE REQUEST FOR INFORMATION. WE WANT THIS, THIS, AND
- 5 THIS, AND NELSON WILL DECIDE HOW HE WANTS TO DO THAT. I
- 6 HAVE TOLD YOU THE MOST I CAN WITHIN THE TIME LIMITS AND THE
- 7 RESOURCES THAT I HAVE.
- 8 MR. CATES: AND WE THANK YOU, AND THE COMMITTEE HAS
- 9 REQUESTED THAT THE DISTRICT PROVIDE TO US A WRITTEN
- 10 RESPONSE TO EACH OF THESE THREE QUESTIONS: STAFF SALARIES,
- 11 LEGAL FEES, AND NORMA COOMBS. THE RESPONSE CAN BE WHATEVER
- 12 YOU WANT, BUT IT SHOULD BE IN WRITING, AND IT SHOULD BE
- 13 RESPONSIVE TO OUR QUESTIONS, AND WITH RESPECT TO HOW THE
- 14 COST OF CONSTRUCTION PROJECTS IS GENERALLY DONE THROUGHOUT
- 15 THE COUNTRY, I DO NOT REGARD AS RESPONSIVE.
- 16 MR. HOCUTT: WE DO HAVE A REQUEST BEFORE THE STAFF TO
- 17 PROVIDE US IN WRITING THE ANSWER TO THESE THREE.
- 18 MR. CATES: THE REQUEST IS TO THE DISTRICT. HOW THE
- 19 DISTRICT DEALS WITH THAT REQUEST IS UP TO US. IT'S NOT
- 20 COMMITTEE TO STAFF. TOO EASY TO DISAVOW.
- 21 STATUS OF SETTLEMENT NEGOTIATIONS. THIS WILL
- 22 TAKE A LONG TIME.
- MR. PEREZ: EXCUSE ME. THAT'S II-IC FOR THE RECORD.
- MR. CATES: III-C.
- NOTHING HAS HAPPENED SINCE OUR MEETING WITH JEFF

- 1 MARTIROSYAN IN NOVEMBER. AFTER THAT MEETING I HAD HOPES
- 2 THAT WE WOULD MAKE SOME PROGRESS. THE BALL WAS IN
- 3 MR. MARTIROSYAN'S COURT TO FOLLOW UP. NOTHING HAS HAPPENED
- 4 SINCE THEN. I DO NOT AT THIS POINT EXPECT ANYTHING TO
- 5 HAPPEN.
- 6 MR. BOLAND: WHAT WERE YOU LOOKING TO SETTLE?
- 7 MR. CATES: ALL OF THE OUTSTANDING ISSUES LIKE THE
- 8 STAFF SALARIES, LEGAL FEES, INADEQUATE NOTICE, FAILURE TO
- 9 RESTORE FUNDS IMPROPERLY SPENT. EVERYTHING THAT WE'VE BEEN
- 10 DISCUSSING, BUT THERE HAS BEEN NO RESPONSE AT ALL.
- 11 MR. BOLAND: STAFF SALARIES. IS A HUNDRED PERCENT OF
- 12 FACILITIES BEING PAID OUT OF TT?
- 13 MR. CATES: THERE'S SEVEN FACILITIES DEPARTMENT
- 14 EMPLOYEES A HUNDRED PERCENT OF WHOSE COMPENSATION IS PAID
- 15 OUT OF TT FUNDS WHEN WE KNOW PERFECTLY WELL THAT NOT ALL OF
- 16 THEIR WORK IS TT RELATED.
- 17 MR. BOLAND: THAT'S --
- 18 MR. PEREZ: NELSON IS 85 BY THE WAY.
- 19 MR. CATES: NO. I SAID WHEN WE KNOW WELL THAT FOR
- 20 THOSE SEVEN EMPLOYEES NOT ALL OF THEIR WORK IS TT RELATED.
- 21 85 PERCENT OF NELSON'S COMPENSATION IS CHARGED TO TT.
- 22 MR. BOLAND: THAT'S HONESTLY WHERE I HAVE AN ISSUE IS
- 23 THE STAFF SALARIES. I DON'T SEE HOW YOU CAN PAY A HUNDRED
- 24 PERCENT OF THOSE GUYS TO TT. I DON'T HAVE AN ISSUE WITH
- 25 THE WAY NELSON'S IS SPLIT UP. I THINK 85 PERCENT OF WHAT

- 1 HE DOES IS RELATED TO TT, BUT THE OTHER PEOPLE THAT'S
- 2 INDEFENSIBLE.
- 3 MR. CATES: RIGHT.
- 4 MS. VANCE: I HAVE ONE QUESTION FOR MIGUEL.
- 5 OUT OF ALL THE PEOPLE THAT WORK FOR NELSON,
- 6 BESIDES KALIL, WHO I KNOW KALIL IS NOT PAID OUT OF TT AT
- 7 ALL. ARE THERE ANY OTHER PEOPLE THAT WORK FOR NELSON THAT
- 8 ARE NOT PAID OUT OF TT?
- 9 MR. PEREZ: WELL, THE WAY WE'RE STRUCTURED IS MEASURE
- 10 TT AND M AND O, MAINTENANCE AND OPERATIONS.
- MS. VANCE: WHO IS UNDER M AND O?
- MR. PEREZ: M AND O IS ONLY SUSIE ALLRED, AND HER
- 13 SALARY IS 50 PERCENT TO MEASURE TT.
- 14 MS. VANCE: SUSIE IS THE ONLY PERSON UNDER M AND O,
- 15 AND 50 PERCENT IS TT?
- 16 MR. PEREZ: YES.
- 17 MS. VANCE: SO WE HAVE ONE M AND O HALF EMPLOYEE
- 18 THAT'S DOING MAINTENANCE AND OPERATIONS ON HOW MANY
- 19 CAMPUSES?
- 20 MR. HOCUTT: TWENTY-SIX CAMPUSES.
- MS. VANCE: TWENTY-SIX. AND WE HAVE ONE FULL-TIME GUY
- 22 THAT'S NOT PAID OUT OF TT WHO RUNS ALL THE JANITORS AND
- 23 THAT'S IT. EVERYONE ELSE IS PAID OUT OF THE BOND. SO MY
- 24 FEAR IS THAT IF AND WHEN THE NEXT BOND DOESN'T PASS, I
- 25 DON'T KNOW HOW THEY'RE GOING TO KEEP THE AIR CONDITIONING

- 1 GOING IN THE SCHOOLS OR CARPET REPLACED, OR, YOU KNOW,
- 2 THAT'S MY CONCERN. AND I UNDERSTAND NELSON'S ARGUMENT THAT
- 3 THERE IS NO OTHER MONEY. LIKE THIS DISTRICT IS IN
- 4 BIG -- THEY HAD TO FILE SOME KIND OF CRAZY
- 5 WE'RE-NOT-GOING-TO-MAKE-OUR-BUDGET, AND THEY'RE GIVING PINK
- 6 SLIPS TO HALF THE PEOPLE OR WHATEVER. I GET THAT, BUT IT

- MR. BOLAND: OKAY. THAT'S BETTER.
- 22 MR. CATES: THERE WAS A CLEAR EXPLANATION OF THE
- 23 PROBLEM AT OUR LAST MEETING, AND IN THAT REGARD I'D LIKE TO
- 24 REFER TO THE VERBATIM TRANSCRIPT FROM OUR LAST MEETING
- 25 BEGINNING AT PAGE 78. SO YOU DON'T HAVE TO FIND IT, LET ME

- 1 READ THE RELEVANT PORTION.
- THERE'S A DISCUSSION ABOUT VARIOUS EXPENSES THAT
- 3 HAVE TO BE PAID. "MS. VANCE" -- THIS IS AT THE BOTTOM OF

- 12 STENOGRAPHER FEES AND ALL OF THAT, AND THAT'S WHY IN THE
- 13 FUTURE MASTER PLAN I HAVE ALLOCATED \$300,000 OUT OF MEASURE
- 14 TT, EVEN THOUGH I KNOW IT'S WRONG, BUT THERE'S NO OTHER
- 15 PLACE FOR THE MONEY TO COME FROM."
- 16 AND IF ANY OF YOU HAVE WONDERED WHY I HAVE BEEN
- 17 OFFENDED FOR SO LONG AT THE CONDUCT OF THE DISTRICT, THE
- 18 DIRECTOR OF FACILITIES HAS JUST EXPLAINED IT. I NEED THE
- 19 MONEY. I'M GOING TO USE IT AS I SEE FIT EVEN THOUGH I KNOW
- 20 IT'S WRONG.
- MS. VANCE: THE EXPLANATION WE GOT, WE ASKED ABOUT ONE
- 22 EMPLOYEE IN PARTICULAR, SHIRLEY BARRETT, WHO USED TO BE IN
- 23 CHARGE OF ALL THE LANDSCAPING AND THE PERMITS.
- MR. BOLAND: SHE'S THE ONE THAT VOLUNTEERS?
- 25 MS. VANCE: YEAH, YOU HEARD THAT PART. THAT'S

- 1 IMPOSSIBLE.
- 2 MR. BOLAND: THAT'S A BAD ANSWER BECAUSE IT'S LIKE A
- 3 SMACK IN THE FACE TO US WHEN YOU TELL US THAT SOMEBODY
- 4 VOLUNTEERS FOR THEIR JOB BECAUSE NOBODY DOES THAT.
- 5 MS. VANCE: I DON'T THINK IT'S SOMETHING THAT WE CAN
- 6 FIX AT THIS POINT.
- 7 MR. BOLAND: NOBODY IS RUNNING HOME WITH THE MONEY.
- 8 THEY'RE PAYING SCHOOL BILLS. IT'S JUST A MATTER OF
- 9 TECHNICALLY YOU CAN'T DO THAT, AND HE EVEN SAYS, "I KNOW I
- 10 CAN'T DO THAT." YOU SHOULD NEVER SAY THAT.
- 11 TELL HIM THAT. YOU SHOULD NEVER SAY THAT.
- MR. CATES: MAYBE A BETTER SOLUTION IS HE SHOULDN'T DO
- 13 IT IN THE FIRST PLACE.
- 14 MR. BOLAND: THAT WOULD BE THE BEST SOLUTION.
- 15 MR. CATES: SINCE THE CALIFORNIA CONSTITUTION SAYS HE
- 16 SHOULDN'T DO IT.
- 17 MR. BOLAND: RIGHT. I AGREE.
- 18 MR. CATES: III-D, REVIEW OF FINAL FINANCIAL AND
- 19 PERFORMANCE AUDITS. I WOULD LIKE TO COMBINE THIS WITH
- 20 III-E WHICH IS A REVIEW AND APPROVAL OF THE FINAL ANNUAL
- 21 REPORT OF THIS COMMITTEE, AND THE REASON IS THAT THE ANNUAL
- 22 REPORT DEALS IN SOME DETAIL WITH THE FINANCIAL AND
- 23 PERFORMANCE AUDITS AT THE END.
- NOW, WE HAD AN EXTENSIVE DISCUSSION OF A DRAFT
- 25 ANNUAL REPORT AT OUR LAST MEETING, AND THERE WERE A NUMBER

- 1 OF COMMENTS, AND THERE WERE REQUESTS FOR AT LEAST FIVE
- 2 CHANGES WHICH I MADE AND DISTRIBUTED TO EVERYONE. THEY'RE
- 3 REFLECTED IN THE CURRENT DRAFT, AND I ALSO RECENTLY MADE
- 4 CHANGES TO REFLECT THE FACT THAT WE GOT A FINAL AUDIT
- 5 REPORT FROM THE AUDITOR EARLY IN THE MONTH. WHAT WE'VE
- 6 BEEN DEALING WITH BEFORE THAT WAS A DRAFT DATED DECEMBER
- 7 30TH. AS I POINTED OUT TO YOU, THE FINAL AUDIT REPORT IS
- 8 DATED DECEMBER 11, 2017.
- 9 WHY WE DID NOT GET IT, WHY IT WASN'T DISTRIBUTED
- 10 UNTIL EARLIER THIS MONTH, I HAVE NO IDEA. THE AUDIT
- 11 PARTNER HAS REPRESENTED THAT THERE ARE NO CHANGES FROM THE
- 12 NOVEMBER 30TH DRAFT TO THE PRESENT VERSION EXCEPT FOR
- 13 FILLING IN DATES AND ADDING SIGNATURES. I SPOT CHECKED THE
- 14 FINAL AGAINST THE DRAFT, AND THAT SEEMS TO BE THE CASE.
- 15 SO WHAT YOU HAVE -- WHAT YOU ALL HAVE BEFORE YOU
- 16 NOW IS A DRAFT DATED TODAY WHICH I WOULD LIKE THIS
- 17 COMMITTEE TO APPROVE.
- 18 MS. VANCE: ARE THERE ANY CHANGES IN YOUR REPORT HERE
- 19 FROM WHAT YOU CIRCULATED VIA EMAIL?
- 20 MR. CATES: WHICH EMAIL?
- MR. HOCUTT: THE EMAIL WAS JANUARY 5TH.
- MR. CATES: AND I CIRCULATED A RED LINE VERSION?
- MR. HOCUTT: YES. A RED LINE VERSION AND A VERSION
- 24 WITHOUT THE RED LINES.
- 25 MS. VANCE: I JUST WANT TO MAKE SURE. I REVIEWED

- 1 THAT, AND I WOULD FEEL CONFIDENT IN APPROVING IT, BUT I
- 2 JUST WANT TO MAKE SURE.
- 3 MR. CATES: LET ME MAKE SURE BECAUSE THERE WAS
- 4 ONE -- AND THE ANSWER IS NO. THE JANUARY 5TH DRAFT IS THE
- 5 LAST. I WOULD LIKE TO RESERVE THE RIGHT TO REVIEW IT AND
- 6 MAKE ANY NECESSARY GRAMMATICAL, PUNCTUATION CHANGES BUT
- 7 NOTHING SUBSTANTIVE.
- 8 MS. VANCE: WHEN DO YOU PRESENT THIS?
- 9 MR. CATES: I DO NOT PLAN TO PRESENT THIS UNTIL THE
- 10 FEBRUARY BOARD MEETING. THE REASON FOR THAT IS THAT THE
- 11 BOARD HAS AN AWFUL LOT ON ITS PLATE INCLUDING SUBJECTS THAT
- 12 ARE PROBABLY OF GREATER IMPORTANCE TO THE BOARD THAN
- 13 RECEIVING OUR ANNUAL REPORT; NAMELY, THE INSOLVENCY OF THE
- 14 DISTRICT, AND WHAT THEY'RE GOING TO DO ABOUT IT.
- 15 MS. VANCE: REALLY?
- 16 MR. CATES: YEAH. I MEAN THE NEGATIVE DECLARATION IN
- 17 EFFECT SAYS THAT WE ARE INSOLVENT.
- 18 MS. VANCE: YEAH, YOU MIGHT NOT WANT TO PRESENT IT IN
- 19 JANUARY.
- MR. BOLAND: IT'S OFF TOPIC, BUT I'M WONDERING WHY
- 21 THEY'RE SPENDING MONEY TRYING TO REMOVE WEED STORES IN THIS
- 22 TOWN WHEN WE COULD ACTUALLY TAP INTO THAT REVENUE FOR THIS
- 23 DISTRICT AND THE CITY. BUT, ANYWAY, I JUST WANTED THAT ON
- 24 THE RECORD.
- 25 MR. HOCUTT: REMOVE WHAT?

- 1 MR. BOLAND: WEED STORES. THEY HAVE A MARIJUANA
- 2 REVENUE THAT THEY COULD TAP INTO, BUT THEY'RE RIGHT NOW
- 3 TRYING TO REMOVE MARIJUANA STORES THAT HAVE BEEN HERE FOR
- 4 SEVEN YEARS. THEY'RE GOING AFTER THE LANDLORDS. THEY'RE
- 5 SPENDING MONEY TO DO THAT.
- 6 MR. HOCUTT: IT'S PROBABLY OUTSIDE OUR PURVIEW.
- 7 MR. CATES: ISN'T THAT A CITY COUNCIL FUNCTION?
- 8 MR. BOLAND: YES, IT IS.
- 9 MR. CATES: AS OPPOSED TO A DISTRICT FUNCTION?
- 10 MS. VANCE: BUT THEY WORK TOGETHER.
- MR. CATES: BUT THEY CAN'T SHARE REVENUES.
- 12 MR. BOLAND: THE CITY COUNCIL CAN DIRECT THE REVENUE
- 13 TOWARDS THE SCHOOL DISTRICT. I JUST SEE REVENUE SOURCES
- 14 AND REVENUE NEEDS, AND THEY'RE BEING IGNORED.
- 15 MR. CATES: YOU'RE RIGHT.
- 16 MS. VANCE: I SEE THAT, BUT I JUST DON'T KNOW IF IT
- 17 WOULD BE THE KIDS IN THE DISTRICT PROVIDING THE REVENUE.
- 18 MR. BOLAND: LIKE I SAID, THE STORES HAVE BEEN HERE
- 19 FOR SEVEN YEARS.
- 20 MS. VANCE: I WILL MAKE A MOTION TO APPROVE BOTH THE
- 21 AUDIT -- I DON'T KNOW THAT WE HAVE TO APPROVE THE AUDIT,
- 22 BUT ACCEPTING THE AUDIT ALONG WITH YOUR ANNUAL REPORT AS
- 23 WRITTEN HERE.
- MR. HOCUTT: I'LL SECOND THAT.
- 25 MR. CATES: ALL IN FAVOR?

- 1 APPROVED SEVEN TO ZERO.
- 2 I'LL PUT THIS INTO FINAL FORM. I'LL DISTRIBUTE
- 3 IT TO THE ENTIRE COMMITTEE.
- 4 MS. VANCE: WILL YOU ALSO SEND US AN EMAIL WHEN YOU'RE
- 5 CONFIRMED ON THE AGENDA TO REMIND US TO COME AND SUPPORT
- 6 YOU?
- 7 MR. CATES: YES, I WILL. I AM NOT ON ANY AGENDA AT
- 8 THIS POINT. I HAVE ASKED KIM TO BE PUT ON THE AGENDA.
- 9 ITEM III-F, THE SELECTION OF ONE OR MORE AUDITORS
- 10 FOR THE FORTHCOMING AUDIT. THE CONTRACT OF NEGRO AND NEGRO
- 11 EXPIRES AT THE END OF THIS FISCAL YEAR.
- 12 MR. BOLAND: YOU HAD AN EXCELLENT DISCUSSION LAST
- 13 MEETING WITH NELSON REGARDING THESE AUDITS, I THOUGHT, AND
- 14 HE SUGGESTED THAT YOU HIRE TWO AUDITORS.
- 15 MR. CATES: RIGHT. NELSON SUGGESTED SEPARATE AUDITORS
- 16 FOR FINANCIAL AND PERFORMANCE, AND TO ME THAT MAKES GOOD
- 17 SENSE.
- 18 MR. BOLAND: I THOUGHT SO TOO.
- 19 MR. CATES: OF COURSE THIS COMMITTEE DOESN'T HAVE THE
- 20 POWER TO SELECT ANYBODY.
- MR. BOLAND: RIGHT.
- 22 MR. CATES: IT'S A DISTRICT FUNCTION.
- MS. VANCE: BUT THEY'VE AGREED TO ALLOW US TO BE
- 24 INVOLVED AND EVEN INVOLVED IN CREATING A SCOPE OF WORK.
- 25 MR. CATES: I THINK WE SHOULD BE INVOLVED. AT THE

- 1 VERY LEAST I THINK WE SHOULD REVIEW THE DISTRICT'S PLAN
- 2 BEFORE THEY ACTUALLY SIGN A CONTRACT.
- 3 MS. VANCE: IS THIS THE LAST YEAR FOR NEGRO AND NEGRO?
- 4 MR. CATES: YES.
- 5 MR. HOCUTT: WHEN WE SAY THE LAST YEAR, WHEN DID THAT
- 6 YEAR --
- 7 MS. VANCE: THE ONE SHE JUST SUBMITTED IS THAT THEIR
- 8 LAST AUDIT?
- 9 MR. CATES: THE LAST ONE UNDER THE EXISTING CONTRACT.
- 10 MS. VANCE: SO THE AUDIT SUBCOMMITTEE GOING FORWARD
- 11 WOULD NEED TO START WORKING WITH THE DISTRICT RIGHT NOW TO
- 12 START THAT SELECTION. START WORKING WITH THE DISTRICT TO
- 13 CREATE THAT SCOPE -- THE DRAFT OF THE SCOPE OF WORK AND
- 14 START BRINGING IN OR PRESENTING AN RFQ, SENDING IT OUT.
- MR. HOCUTT: WE ARE HALFWAY THROUGH THE YEAR.
- 16 MS. VANCE: THEY'RE GOING TO NEED TO START AS SOON AS
- 17 WE HIRE THEM.
- 18 MR. CATES: GRETCHEN, I AGREE.
- 19 MIGUEL, THIS IS IMPORTANT, AND I DON'T THINK IT'S
- 20 CONTROVERSIAL. WOULD YOU PLEASE ASK NELSON TO BEGIN THE
- 21 PROCESS FOR THE SELECTION OF AN AUDITOR OR AUDITORS FOR THE
- 22 FORTHCOMING YEAR OR TWO OR THREE, WHATEVER THE DESIRED
- 23 PERIOD IS. THAT COULD BE NEGRO AND NEGRO, BUT I THINK THE
- 24 DISTRICT NEEDS TO CONSIDER AT LEAST SEVERAL QUALIFIED

- 4 COMMENT. READING THE LAST MONTH MEETING MINUTES, THERE WAS
- 5 SOMETHING ABOUT SCOPES AND CERTAIN PECULIARITIES THAT SOME
- 6 MEMBERS OF THE COC MENTIONED. SO I WOULD SAY, YES, THE
- 7 DISTRICT CAN START ON THAT, BUT IT WILL BE GOOD IF YOU GUYS
- 8 CAN PRODUCE SOMETHING TO BE ADDED TO THAT REQUEST. IF YOU
- 9 READ THE MEETING MINUTES --
- 10 MR. CATES: MIGUEL, THE DISTRICT ALREADY HAS IT. JUST

- 13 AUDITS DON'T DO THAT THEY SHOULD DO.
- 14 MR. PEREZ: OKAY. I JUST WOULD LIKE TO MAKE THINGS
- 15 SMOOTH FOR EVERYBODY, AND IF YOU AT THE MEETING JUST SAID,
- 16 WELL, IT'S VERY -- THERE'S 103 PAGES OF THE DECEMBER
- 17 MINUTES, AND THERE WERE LIKE 60 PAGES DEDICATED TO THE
- 18 AUDITORS, AND THERE WAS SPECIFIC COMMENTS, IF I DON'T
- 19 REMEMBER WRONGLY, BUT JAMES VITALE WAS HIGHLY INVOLVED ON
- 20 WHAT SHOULD BE REQUESTED. SO IF YOU CANNOT PRODUCE THAT,
- 21 OKAY.
- MR. HOCUTT: BUT CLIFF IS CORRECT. IN THE ANNUAL
- 23 REPORT THAT WE'VE JUST APPROVED, NELSON SHOULD READ THROUGH
- 24 THAT --
- MR. BOLAND: I KNOW WHAT YOU'RE TALKING ABOUT, AND I

- 1 CAN FIND IT FOR YOU. I READ JAMES'S COMMENTS ON THAT.
- 2 IT'S THE SCOPE, AND THAT'S WHY I LIKED THAT DISCUSSION
- 3 BECAUSE IF YOU GET TO THE SCOPE OF THOSE AUDITS PROPERLY AT
- 4 THE BEGINNING, WE'RE NOT GOING TO BE WHERE WE ARE TODAY AT
- 5 THE END. THAT'S THE KEY TO FIXING WHAT YOU WANT FIXED.
- 6 MR. PEREZ: THAT'S WHY I WOULD LIKE TO GET SOMETHING
- 7 CLEAR FROM YOU AND NOT THE AMBIGUITY OF THERE ARE MY
- 8 COMMENTS OVER THERE. BECAUSE THAT COULD BE INTERPRETED IN
- 9 DIFFERENT MANNER INSTEAD OF YOU GUYS ARE ABLE TO PRODUCE
- 10 SOMETHING. DISCLOSURE SHOULD INCLUDE A, B, C. AND SO THAT
- 11 WOULD HELP, BUT YOU -- I'M JUST ALMOST A BYSTANDER, AND I
- 12 TRY TO GIVE MY TWO CENTS TO TRY TO MAKE THINGS BETTER FOR
- 13 ALL OF US.
- 14 MS. VANCE: HERE'S WHAT I SUGGEST. I SUGGEST THAT YOU
- 15 GIVE US THE SCOPE THAT WE USED TO SELECT NEGRO AND NEGRO.
- 16 WE TAKE THE SCOPE, WE CAN ADD WHAT WE WANT TO THE SCOPE AND
- 17 SEND IT BACK TO YOU, AND THEN YOU CAN EITHER -- YOU CAN
- 18 DECIDE WHAT YOU DO WITH IT. SOMEBODY NEEDS TO START THE --
- 19 MR. CATES: RIGHT. AND IT'S NOT OUR PROCESS TO START.
- MS. VANCE: NO. SO IF YOU GIVE US THE SCOPE, IF YOU
- 21 GO BACK -- JOHN POPOLARDO PUT IT TOGETHER. I WAS THERE
- 22 WHEN WE HANDED IT TO THE AUDITORS. MAYBE I HAVE IT IN MY
- 23 PAPERWORK SOMEWHERE, BUT THERE SHOULD BE SOMEWHERE AT THE
- 24 DISTRICT A SCOPE OF WORK FOR SELECTING BOND AUDITORS AND
- 25 FIND THAT AND SEND THAT TO US, AND WE CAN REVIEW THAT, AND

- 1 WE CAN INCLUDE THAT AS AN ITEM ON OUR MINUTES. NO. THE
- 2 SUBCOMMITTEE SHOULD DO IT.
- 3 MR. CATES: AND WE ALREADY HAVE, GRETCHEN. THE ANNUAL
- 4 REPORT IS A STINGING CRITIQUE OF THE LIMITED SCOPE OF THE
- 5 AUDIT.
- 6 MR. HOCUTT: I THINK HER REQUEST IS A GOOD ONE.
- 7 LET ME ALSO ADD, MIGUEL, LET'S NOT WAIT UNTIL THE
- 8 NEXT COC COMMITTEE MEETING TO DO THAT. WE'VE GOT FIVE MORE
- 9 MEETINGS BEFORE THIS YEAR IS OVER, AND I KNOW THE DISTRICT
- 10 SORT OF TAKES ADVANTAGE OF THE FACT THAT WE MEET ONCE A
- 11 MONTH.
- 12 MS. VANCE: I DON'T THINK IT WILL TAKE THAT LONG TO
- 13 PULL THAT STUFF UP.
- MR. HOCUTT: WE NEED INPUT. YOU CAN GET IT TO THE
- 15 AUDIT SUBCOMMITTEE. THAT AUDIT SUBCOMMITTEE CAN MEET,
- 16 DISCUSS, GET BACK TO YOU. LET'S NOT WAIT FOR THE FULL
- 17 COMMITTEE.
- 18 MR. PEREZ: I WILL PASS IT ON TO MY BOSS.
- 19 MR. CATES: I HAVE THE SCOPE OF THE AUDITOR'S
- 20 RESPONSIBILITIES ON THE HARD DRIVE OF MY COMPUTER, AND I
- 21 BELIEVE -- I'M NOT SURE -- BUT I BELIEVE THAT AT SOME POINT
- 22 I HAVE SENT IT TO ALL OF YOU, BUT IT'S SET FORTH IN A
- 23 CONTRACT. THE CONTRACT SAYS EXACTLY WHAT THE AUDITORS WERE
- 24 REQUIRED TO DO.
- 25 MS. VANCE: IT'S FROM THE DISTRICT?

- 1 MR. BOLAND: AND JAMES HAD SOME SPECIFIC COMMENTS AS
- 2 TO WHAT HE THOUGHT SHOULD BE ADDED.
- 3 MR. CATES: EXACTLY. BUT WE HAVE VERY SPECIFIC
- 4 CRITICISMS OF THE SCOPE, THE EXISTING SCOPE OF THE AUDITORS
- 5 WORK, AND THEY'RE SET FORTH IN THE ANNUAL REPORT THAT WE
- 6 JUST ADOPTED. THAT'S A REALLY GOOD STARTING PLACE. THE
- 7 BASIC PROBLEM IS THAT UNDER THE EXISTING SCOPE OF WORK, THE
- 8 AUDITOR IS ALLOWED TO DISCLAIM THINGS THAT ARE NECESSARY TO
- 9 MAKE THE AUDIT REPORT MEANINGFUL.
- 10 MS. VANCE: BUT I'M NOT TALKING ABOUT THE CONTRACT
- 11 THAT WAS SIGNED WITH NEGRO AND NEGRO. I'M TALKING ABOUT A
- 12 SCOPE OF WORK THAT YOU SEND OUT WITH AN RFQ WHEN YOU GO OUT
- 13 TO HIRE NEW AUDITORS.
- MR. HOCUTT: A MODIFIED SCOPE.
- 15 MS. VANCE: THAT'S WHAT I AM TALKING ABOUT.
- 16 MR. CATES: SORRY. I UNDERSTAND NOW. I DO NOT HAVE
- 17 THAT.
- 18 MR. BOLAND: NELSON SAID HE WAS GOING TO PULL THAT
- 19 TOGETHER. HE SAID AT THE LAST MEETING HE WAS GOING TO
- 20 START PUTTING AN RFQ TOGETHER; IS THAT CORRECT?
- MR. CATES: FRANCIS, I HONESTLY DON'T REMEMBER.
- 22 MR. BOLAND: I'M NOT SURE IF I'M CORRECT. I THOUGHT
- 23 THAT'S WHAT I READ THAT HE SAID HE WAS GOING TO START
- 24 PUTTING THAT TOGETHER, AND EVERYBODY AGREED THAT THERE
- 25 WOULD BE TWO AUDITORS, ONE FOR FINANCIAL AND ONE FOR

- 1 PERFORMANCE, AND BETWEEN THE TWO OF THEM YOU WOULD COME TO
- 2 THESE CONCLUSIONS THAT ARE MISSING OUT OF THIS, AND THEY
- 3 ONLY GOT PAID \$12,000.
- 4 MR. CATES: LESS, I THINK.
- 5 MR. BOLAND: THAT IS THE KEY. A BETTER AUDIT AND TWO
- 6 AUDITORS.
- 7 MR. CATES: WILL YOU CONVEY OUR URGENT REQUEST THAT
- 8 THE DISTRICT START THE PROCESS?
- 9 MR. PEREZ: OKAY. I WILL LET HIM KNOW. WE USUALLY
- 10 HAVE A REVIEW OF WHAT HAPPENED AT THE COC THE NEXT DAY, BUT
- 11 SINCE NELSON IS OUT, WE MIGHT NOT HAVE IT TOMORROW, BUT
- 12 NEXT MONDAY. THAT'S THE NORMAL PROCESS. WE HAVE OUR
- 13 MEETINGS ON WEDNESDAY NIGHT, AND THURSDAY I INFORM ABOUT
- 14 IT.
- 15 MR. CATES: THERE HAS BEEN NO CHANGE TO THE ANNUAL
- 16 REPORT INSOFAR AS IT DEALS WITH THE AUDIT REPORT.
- 17 MR. PEREZ: OKAY. IT'S ALSO IN THE MINUTES.
- 18 MR. CATES: YOU'VE HAD IT.
- 19 MR. PEREZ: HE GETS THE VERBATIM ALSO.
- MR. HOCUTT: WOULD YOU BE OKAY WITH RESPONDING TO US
- 21 AFTER YOU HAVE THAT MEETING?

- 1 MR. CATES: FRANCIS MENTIONED THE FEE CHARGED BY NEGRO
- 2 AND NEGRO, WHICH ACCORDING TO MY RECOLLECTION IS SOMETHING
- 3 A LITTLE BIT LESS THAN \$12,000. THERE IS NO WAY THAT THE
- 4 DISTRICT CAN GET AN ADEQUATE AUDIT FOR THAT SUM. NONE AT
- 5 ALL. THAT'S A JOKE. NOW, AUDIT FEES CAN GET PAID OUT OF
- 6 TT FUNDS. SO THAT'S NOT A PROBLEM, BUT YOU BASICALLY GET
- 7 WHAT YOU PAY FOR, AND THE DISTRICT GOT WHAT IT PAID FOR.
- 8 SO YOU WILL CONVEY OUR URGENT REQUEST.
- 9 ITEM III-G, REVIEW OF ANY BOARD REPORTS.
- 10 QUINCY.
- 11 MR. HOCUTT: WE DO HAVE SOME BOARD REPORTS. MIGUEL
- 12 HAS PASSED OUT A SHEET. I WASN'T ABLE TO GET THESE TO YOU
- 13 BEFORE THIS. BY THE WAY, THERE ARE TWO PAGES.
- 14 MR. PEREZ: LOOK AT THE BACK.
- 15 MR. HOCUTT: YOU'RE SO GOOD. YOU'RE SO GOOD.
- 16 MR. PEREZ: LET ME MAKE A COMMENT NOW THAT I HAVE THE
- 17 FLOOR.
- 18 THESE BOARD REPORTS WERE IN DRAFT WHEN I SEND
- 19 THEM TO YOU. OKAY? THIS AFTERNOON I RECEIVED THE FINAL
- 20 ONES. SO FOR YOUR INFORMATION --
- MR. HOCUTT: ARE THEY THE SAME?
- 22 MR. PEREZ: THE SAME BUT NOT EXACTLY THE SAME.
- 23 THEY'RE NOT EQUAL. I HAVE THEM. THERE'S SLIGHT CHANGES.
- 24 MS. VANCE: DO YOU HAPPEN TO KNOW WHAT THE CHANGES
- 25 ARE?

- 1 MR. PEREZ: NO, I HAVEN'T HAD THE TIME TO REVIEW THEM.
- 2 BUT I KNOW THAT THERE IS ONE MORE FOR A CHANGE ORDER FROM
- 3 NASARYAN, AND THERE'S A DIFFERENT AMOUNT IN THE FIRST ONE,
- 4 1264-F, THAT THE AMOUNT WAS REDUCED, BUT I BELIEVE THAT THE

- 9 MR. HOCUTT: I WANT TO RUN THROUGH THEM BRIEFLY.
- 10 1264-F WAS FOR A CHANGE ORDER FOR G2K CONSTRUCTION FOR THE
- 11 WASHINGTON ELEMENTARY SCHOOL. THAT'S THE INFAMOUS
- 12 ELEMENTARY SCHOOL.
- 13 MS. VANCE: THAT'S THE PROBLEM; RIGHT?
- 14 MR. HOCUTT: THE ARGUMENT FOR APPROVING THIS -- THIS
- 15 WAS \$265,000 FOR A CHANGE ORDER, AND YOU'VE SAID IT COULD
- 16 BE A LITTLE BIT LESS THAN THAT NOW. BUT THE ARGUMENT TO
- 17 APPROVE IT, AS STATED IN THE BR, WAS IT COVERS UNFORESEEN
- 18 CONDITIONS AND ARCHITECT/DISTRICT REQUESTED CHANGES.
- 19 IF WE'RE DOING ALL THESE NEEDS ANALYSES, AND WE
- 20 HAVE FULL-TIME INSPECTORS AND AT LEAST MORE THAN ONE AT
- 21 WASHINGTON, HOW DO WE GET ALL OF THESE UNFORESEEN
- 22 CONDITIONS THAT NECESSITATE A QUARTER OF A MILLION DOLLAR
- 23 CHANGE ORDER?
- AND, BY THE WAY, SO THE COMMITTEE WILL KNOW, BY
- 25 LAW THESE CHANGE ORDERS ARE SUPPOSED TO BE LIMITED TO 10

- 1 PERCENT OF THE TOTAL CONSTRUCTION BUDGET WHICH MAKES HOW
- 2 DID YOU GET THE BUDGET AN IMPORTANT QUESTION. THIS CHANGE
- 3 BRINGS IT UP TO 16 PERCENT.
- 4 MS. VANCE: AND IT EXCEEDS THE LIMITATION SET FORTH IN
- 5 THE PUBLIC CONTRACT CODE.
- 6 MR. HOCUTT: YES.
- 7 MR. BOLAND: IS THAT THE 2008 BUDGET?
- 8 MS. VANCE: THESE BUDGETS ARE I THINK -- WE NEVER KNOW
- 9 WHERE THESE NUMBERS ARE COMING FROM.
- 10 MR. HOCUTT: I PRESUME IT WAS THE LAST BUDGET.
- 11 MR. PEREZ: EXCUSE ME. IF YOU READ THE SUPPORTING
- 12 DOCUMENTATION, THEY SHOW EXACTLY WHERE THEY COME FROM. FOR
- 13 INSTANCE, ON THIS 1264-F THERE ARE 14 ITEMS. IT'S MISSING
- 14 THE BACK UP. PLEASE READ IT. BECAUSE I TOOK THE TIME TO
- 15 READ IT. EVERY ONE OF THEM IS IDENTIFIED. EXHIBIT 8, PAGE
- 16 3, AND THERE ARE 14 DIFFERENT ITEMS. I'M NOT GOING TO READ
- 17 ALL OF THEM BECAUSE YOU ALREADY HAVE THEM, AND THERE IS
- 18 ALSO ANOTHER COMMENT. I BELIEVE THAT YOU MADE A LITTLE
- 19 MATH ERROR, AND THE PERCENTAGE IS 11.37.
- 20 MR. HOCUTT: I COPIED THE PERCENTAGES OUT OF THE BOARD
- 21 REPORTS.
- MR. PEREZ: ME TOO. I HAVE IT HERE. I'M NOT GOING TO
- 23 DISCUSS, BUT IF YOU DIVIDE 265 DIVIDED BY 14 MILLION,
- 24 IT'S -- I CHECK IT TWICE. ANYWAY, THE OBJECT OF THE
- 25 DISCUSSION IS NOT THE MATHEMATICS. YOU MENTION THAT IT'S

- 1 OVER THE 10 PERCENT. YES, THERE IS. AND THERE ARE PLENTY
- 2 OF THINGS THAT WERE NEEDED, AND THIS COULD NOT BE
- 3 IDENTIFIED IN -- HOW YOU CALL IT? -- THE NEEDS ANALYSIS.
- 4 NO.
- 5 MR. HOCUTT: THAT IS AN ARGUMENT THAT I WOULD LIKE TO
- 6 HAVE AT LEAST THIS COMMITTEE TO HEAR FOR JUST A SECOND.
- 7 LET ME SAY THIS. A CHANGE REQUEST IS SUPPOSED TO BE
- 8 SOMETHING THAT IS REALLY UNFORESEEN, UNKNOWN. ARCHITECTS
- 9 STARTING DIDN'T KNOW THAT THIS CHANGE ORDER OCCURRED. FOR
- 10 EXAMPLE, YOU FOUND A HUGE SINKHOLE BENEATH THE SCHOOL. YOU

- 18 CHANGED IN TIME. I DON'T KNOW, GRETCHEN, YOU MIGHT HELP ME
- 19 OUT. WHEN DID THIS PROJECT START?
- 20 MS. VANCE: I DON'T EVEN KNOW. I WASN'T KEEPING TRACK
- 21 OF WASHINGTON.
- 22 MR. PEREZ: I'M SURE IT'S BEFORE NELSON'S TIME, AND
- 23 THE PRINCIPALS CHANGE, AND THEY MAKE REQUESTS. WE NEED
- 24 THIS, AND WE NEED THAT. ONCE YOU ARE UNDER CONSTRUCTION,
- 25 IT'S EASIER TO ACCOMMODATE THOSE WISHES IF THEY'RE

- 1 REASONABLE. AND AS I TOLD YOU, I HAVE THE LIST HERE.
- 2 THERE ARE 14 DIFFERENT ITEMS THAT THESE COULD NOT BE
- 3 FORESEEN.
- 4 MR. HOCUTT: FOR EXAMPLE, YOU DIDN'T KNOW THAT YOU
- 5 NEEDED LIGHT FIXTURES IN BUILDING C, ROOM 202 AND 209? DID
- 6 YOU DESIGN THE CLASSROOM WITH NO LIGHT FIXTURES?
- 7 MR. PEREZ: BUT MAYBE THEY'RE GOING TO BE USED FOR
- 8 SOMETHING ELSE THAN THE DESIGN. I'M JUST -- YOU KNOW, AT
- 9 THE END OF THE DAY, I CANNOT GIVE YOU THE DETAIL. YOU
- 10 WOULD HAVE TO MEET WITH THE PROJECT MANAGER AND HE EXPLAIN
- 11 ALL OF THIS, BUT AT SOME POINT IN TIME THE DISTRICT, NELSON
- 12 HAS TO TRUST THAT THE PROJECT MANAGER KNOWS WHAT HE'S
- 13 DOING, AND HE HAS CONVERSATION WITH THEM IN REGARDS TO WHAT
- 14 EVERY ONE OF THESE ITEMS IN THE CHANGE ORDERS ARE FOR. SO
- 15 IT'S NOT -- THESE ARE THINGS THAT CANNOT BE FORESEEN IN THE

- 17 MR. CATES: LIGHTING FIXTURES IN ROOMS?
- 18 MR. PEREZ: YES. WHAT HAPPENS IF YOU HAVE A ROOM FOR
- 19 ONE THING AND THEN YOU REALIZE THAT THE LIGHTS ARE NOT
- 20 ENOUGH? WHAT DO YOU DO? DO YOU COMPLETE THE PROJECT AND
- 21 THEN YOU BREAK THE CEILING TO CHANGE THE LIGHTS FOR WHAT
- 22 YOU REALLY NEED? THAT'S NOT IN THE GOOD INTERESTS OF THE
- 23 TAXPAYERS.
- 24 MR. HOCUTT: PROVIDE AND INSTALL STORM WATER RETENTION
- 25 SYSTEM WEST OF BUILDING C. YOU DIDN'T KNOW YOU NEEDED A

- 1 STORM --
- 2 MR. PEREZ: EVIDENTLY NOT BECAUSE OTHERWISE WE WOULD
- 3 HAVE ASKED FOR IT PREVIOUSLY.
- 4 MR. HOCUTT: \$132,000. AND YOU DIDN'T REALIZE --
- 5 MR. BOLAND: HE CAN'T ANSWER THAT STUFF.
- 6 MR. HOCUTT: I KNOW HE CAN'T. DOES THE DISTRICT KNOW
- 7 HOW TO SAY NO TO THE PRINCIPAL? OKAY.
- 8 MR. BOLAND: YOU DON'T KNOW THAT THEY DIDN'T EITHER.
- 9 MR. HOCUTT: DO WE WANT TO GO THROUGH THESE AND VOTE
- 10 ON EACH ONE AS WE GO?
- 11 MS. VANCE: MY QUESTION ON THIS IS -- AND I DON'T HAVE
- 12 THE PAPERWORK WITH ME. I DON'T KNOW IF ANYONE DOES. WHAT
- 13 WAS THE ORIGINAL 2012 BUDGET FOR WASHINGTON?
- 14 MR. HOCUTT: ACCORDING TO THIS DOCUMENT I'M LOOKING
- 15 AT, THE ORIGINAL BUDGET WAS FOR \$14.4 MILLION. IT HAD
- 16 PREVIOUS CHANGES THAT BROUGHT IT UP TO 15.8. THIS BRINGS
- 17 IT UP TO 16.1. MY OUESTION FOR THE STAFF IS IS 16.1 THE
- 18 NEW NUMBER IN THE NEW SPEND OUT PLAN?
- 19 MR. PEREZ: THE SPEND OUT PLAN IS NOT READY. THEY
- 20 WERE WORKING ON IT TODAY. I SENT YOU AN EMAIL, AND I DON'T
- 21 KNOW -- I DON'T KNOW THE ANSWER TO THAT.
- 22 MR. HOCUTT: DO THEY CHANGE THE BUDGET?
- 23 MR. PEREZ: THERE ARE CHANGES TO WHAT WE CALL THE
- 24 PRIORITY LIST, AND I'M NOT AWARE IF THAT CHANGE, HOW IT
- 25 IMPACTS WHAT YOU'RE SAYING.

- 1 MR. HOCUTT: BUT THIS COULD MEAN THAT SOMETHING
- 2 FURTHER DOWN THE LIST WILL NOW FOR SURE NOT GET DONE.
- 3 MR. PEREZ: WE HAVE A CONTINGENCY. WE HAVE A 9
- 4 PERCENT CONTINGENCY, BUT I CANNOT ANSWER YOUR QUESTION.
- 5 MR. HOCUTT: DO YOU WANT TO GO THROUGH THESE AND VOTE
- 6 EN MASSE?
- 7 MS. VANCE: HERE'S WHAT I FIND INTERESTING.
- 8 MR. CATES: LET'S ANSWER QUINCY'S QUESTION FIRST.
- 9 MR. HOCUTT: SHOULD WE RUN THROUGH THEM QUICKLY?
- 10 MR. CATES: YES.
- 11 MR. HOCUTT: YOU HAD A QUESTION ON 1264?
- MS. VANCE: WHAT I THINK IS INTERESTING WHERE IT SAYS
- 13 FISCAL IMPACT. FUNDS NOT TO EXCEED 265 ARE AVAILABLE IN
- 14 WASHINGTON SCHOOL MEASURE TT ACCOUNT. I DON'T UNDERSTAND
- 15 HOW IF IT'S SO MUCH OVER BUDGET AND MAYBE EVEN OVER THE
- 16 CONTINGENCY AMOUNT, BECAUSE IF YOU HAVE 9 PERCENT IN
- 17 CONTINGENCY AND THEN YOU'RE 11 PERCENT OVER, HOW YOU COULD
- 18 POSSIBLY HAVE \$265,000 AVAILABLE IN THAT ACCOUNT. I KNOW
- 19 THAT WE'RE TALKING IN CIRCLES, BUT YOU GET WHAT I'M SAYING
- 20 HERE; RIGHT?
- MR. HOCUTT: I DO BECAUSE THE POINT THAT YOU'RE MAKING
- 22 TO ME IS THAT THESE BUDGETS AREN'T BUDGETS AT ALL. IN MANY
- 23 CASES THERE'S A NUMBER THROWN OUT THERE, AND THEN WE GO
- 24 THROUGH TONS OF BRS WHICH DON'T SEEM TO AFFECT THE BUDGET
- 25 AT ALL. IN FACT, NELSON HAS STATED IN THE PAST, "OH, IT

- 1 WAS IN THERE." HOW COULD IT HAVE BEEN IN THERE BEFORE YOU
- 2 HAD THE BR TO TALK ABOUT IT? SO, YEAH, THAT'S WHY I ASKED
- 3 WOULD THIS CHANGE THE BUDGET NUMBER ON THE NEW PRIORITY
- 4 SPENDING PLAN WHICH --
- 5 MS. VANCE: THAT MAKES SENSE.
- 6 MR. HOCUTT: IT DOES MAKE SENSE. TO ME THAT IS WHAT
- 7 THIS IS FOR. YOU HAVE A BUDGET OF A MILLION DOLLARS TO DO
- 8 SOMETHING. YOU DECIDE THAT WE FORGOT TO PUT A WING ON THE
- 9 SCHOOL SO WE HAVE TO ADD \$500,000. THE NEW BUDGET BECOMES
- 10 1.5, NOT IT WAS ALREADY IN THERE.
- 11 MS. VANCE: I DO NOTICE THAT THESE REPORTS ARE NOW
- 12 MORE DETAILED THOUGH.
- 13 MR. HOCUTT: 1265 IS ANOTHER CONTRACT INCREASE FOR
- 14 INSPECTION AT WASHINGTON ELEMENTARY, THE SAME SCHOOL. THE
- 15 STATED ARGUMENT FOR IT WAS THE INCREASE IS DUE TO EXTENDED
- 16 CONSTRUCTION DURATION AND CONTRACTOR CORRECTIVE WORK. I
- 17 LOVE IT. ONE EXAMPLE THAT I SAW WAS THAT THEY HAVE TO
- 18 REWELD STEEL HEADERS BECAUSE THEY WERE WELDED IN THE WRONG
- 19 POSITIONS. THEY HAD TO BREAK IT APART AND REWELD.
- THE INSPECTORS ARE DOING WHAT WHILE THEY'RE
- 21 INSPECTING?
- 22 MR. PEREZ: THE INSPECTORS DO NOT HAVE THE POWER TO
- 23 MAKE DECISIONS. THEY NOTIFY. OKAY.
- MR. HOCUTT: WHO DO THEY NOTIFY?
- 25 MR. PEREZ: THE PROJECT MANAGER. BUT LET ME -- HAVE

- 1 YOU FINISHED WHAT YOU WERE SAYING? LET ME GIVE AN
- 2 EXPLANATION.
- 3 MR. HOCUTT: LET ME ADD ONE THING, AND YOU CAN
- 4 EXPLAIN. READ THE ARGUMENT AGAINST APPROVAL. ORIGINAL
- 5 CONSTRUCTION DUE DATE WAS AUGUST 2016. THE NEXT COMPLETION
- 6 EXPECTED DATE IS NOW JANUARY 2018. JANUARY 2018 IS WHAT'S
- 7 IN YOUR CONSTRUCTION STATUS REPORT. IT ALSO SHOWS THAT
- 8 YOU'RE 93 PERCENT DONE WITH WASHINGTON WHICH MEANS YOU HAVE
- 9 7 PERCENT TO GO. THIS IS THE MIDDLE OF JANUARY. YOU'RE
- 10 GOING TO FINISH UP 7 PERCENT OF THE WORK AND COMPLETE THIS
- 11 PROJECT IN JANUARY WHICH IS WHAT YOUR CONSTRUCTION STATUS
- 12 REPORT SCHEDULE SHOWS?
- 13 MR. PEREZ: THE ADJUSTED CONSTRUCTION STATUS REPORT
- 14 THAT YOU HAVE IN THIS 11 X 17 SHEET --
- 15 MR. HOCUTT: THE ONE THAT I GOT BEFORE THAT. OKAY.
- 16 WHAT'S THE NEW DATE?
- 17 MR. PEREZ: IT SAYS MPR, MULTIPURPOSE ROOM,
- 18 MID-FEBRUARY 2018, AND CLASSROOM BUILDING LATE MARCH 2018.
- 19 THAT'S THE LATEST.
- 20 MR. HOCUTT: DOES ANYBODY THINK THAT A DELAY IN
- 21 CONSTRUCTION WOULD ADD TO THE COST?
- 22 MR. BOLAND: I THINK THAT I DON'T HAVE ENOUGH
- 23 INFORMATION ON HERE, QUINCY, TO DECIDE ONE WAY OR THE
- 24 OTHER.
- 25 MR. HOCUTT: WOULD YOU NOT WANT TO BE ON THE

- 1 FACILITIES COMMITTEE?
- 2 MR. BOLAND: IF THEY NEED THE MONEY, THEY NEED THE
- 3 MONEY, BUT I CAN'T MAKE AN INFORMED DECISION AGAINST IT
- 4 HERE.
- 5 MR. PEREZ: MAINLY THE REASON FOR THESE BOARD REPORTS
- 6 IS THAT WE ARE STILL UNDER CONSTRUCTION, AND WE NEED TO
- 7 HAVE AN INSPECTOR. THAT'S A NO BRAINER. WE HAVE TO.
- 8 OKAY? AND WHO'S GOING TO PAY FOR IT? US. OKAY? AND THIS
- 9 IS MANAGED ALREADY BY THE INSURANCE COMPANY, AND I AM SURE
- 10 THAT THIS WILL BE PART OF THE ARGUMENTS THAT THE CITY WILL
- 11 HAVE AGAINST THE SURETY BECAUSE WE HAVE HAD TO PAY
- 12 ADDITIONAL TIMES FOR THE ARCHITECT, FOR THE ENGINEER OF

- 18 FOR IT.
- 19 MS. VANCE: I HAVE A GENERAL QUESTION ON THAT. I
- 20 DON'T KNOW ENOUGH ABOUT -- I FORTUNATELY HAVE NEVER HAD TO
- 21 FILE A BOND -- FILE A CLAIM AGAINST A BOND THAT I'VE
- 22 COLLECTED AT WORK. BUT WHEN DO YOU GET THE MONEY BACK FROM
- 23 THE PERFORMANCE BOND OR THE SURETY COMPANY? WHEN DOES THAT
- 24 GET REIMBURSED BACK?
- MR. PEREZ: THAT'S AN-IMPOSSIBLE-TO-ANSWER QUESTION.

- 1 THERE WILL BE NORMALLY NEGOTIATIONS, AND LAWYERS ARE
- 2 INVOLVED.
- 3 MS. VANCE: SO NONE OF THE MONEY HAS BEEN --
- 4 MR. PEREZ: AT THE END OF THE PROJECT THE DISTRICT
- 5 WILL HAVE TO SIT DOWN WITH THE INSURANCE COMPANY AND SAY,
- 6 HEY, THIS COMPANY DID NOT PERFORM BECAUSE THIS, BECAUSE
- 7 THEY DID THIS WRONG AND DID THIS AND THIS AND THIS. THIS
- 8 COST US -- THIS DELAY IMPACTED US IN THIS AMOUNT, AND THEY

- 18 MS. VANCE: SO WHAT IF YOU HAVE A DISTRICT THAT
- 19 DOESN'T HAVE A POT OF TT GOLD THAT THEY CAN'T JUST FRONT

- 6 MS. VANCE: I'M JUST WONDERING.
- 7 MR. PEREZ: YEAH, ME TOO. BUT AT SOME POINT IN TIME
- 8 THAT SCHOOL WILL HAVE TO FINISH, OR WE WILL BE LIKE MANY
- 9 BUILDINGS WE HAVE IN SOUTH AMERICA THAT ARE BUILT AT 40
- 10 PERCENT, AND YOU HAVE THE STRUCTURE, AND THEY'RE WAITING.
- 11 IT'S A HOSPITAL, BUT THERE'S NO MONEY. IT DETERIORATES.
- 12 IT HAPPENS.
- 13 MR. HOCUTT: MOVING ON, 1266 IS A CHANGE ORDER FOR
- 14 BLAIR. I WISH STEVE WERE HERE. INTERESTING IT SAID THAT
- 15 THIS BRINGS THE CONTRACT VALUE TO \$20.8 MILLION, BUT WHEN I
- 16 LOOKED AT THE LAST PRIORITY LIST I HAD, BLAIR WAS \$24
- 17 MILLION. AM I READING SOME NUMBERS WRONG, OR IS THIS BR
- 18 INCORRECT? ANYWAY, AGAIN UNFORESEEN CONDITIONS, AND THE
- 19 ARCHITECT AND DISTRICT REQUESTED SCOPE CHANGES. MY
- 20 FAVORITE WAS THEY DECIDED TO ADD A SINK, A FAUCET, AND HOT
- 21 WATER TO THE JANITOR'S CLOSET. WOULD ANYBODY HERE DESIGN A
- 22 JANITOR'S CLOSET WITHOUT A SINK AND HOT WATER? JUST
- 23 ASKING. SOME OF THIS IS JUST MIND BOGGLING.
- MR. PEREZ: I PROVIDED YOU THIS LIST, THIS TABLE WITH
- 25 THE 14 ITEMS THAT QUINCY IS REFERRING TO, AND MAKING

- 1 REFERENCE TO THE NEEDS ANALYSIS THAT YOU MENTION AS AN
- 2 ARGUMENT AGAINST APPROVAL? LET ME TELL YOU, QUINCY, THAT I
- 3 DON'T KNOW HOW TO SAY THIS IN A SWEET MANNER. IT'S EITHER
- 4 THERE IS NOT ENOUGH KNOWLEDGE ABOUT WHAT THE NEEDS ANALYSIS
- 5 COMPREHENDS OR UNFORESEEN CONDITION IS SOMETHING THAT'S NOT
- 6 CLEAR. FOR INSTANCE, HERE THEY -- ITEM NO. 2 OR NO. 1.
- 7 THE BAND ROOM DAMAGE WAS VISIBLE AFTER REMOVAL OF A RAISED
- 8 WOODEN PLATFORM. THERE IS NO WAY ANYBODY IN A NEEDS
- 9 ANALYSIS CAN KNOW THIS.
- 10 MR. HOCUTT: SOME OF THIS, YES.
- 11 MR. PEREZ: THEY DON'T HAVE X RAYS.
- 12 EXISTING CONCRETE BIN AT LOWER LEVEL WAS TOO
- 13 WIDE.
- 14 MR. HOCUTT: LET ME BACK UP A LITTLE BIT.
- 15 MR. PEREZ: LET ME FINISH.
- 16 MR. HOCUTT: I WANT TO MAKE THIS POINT WHILE PEOPLE
- 17 ARE LISTENING. I'VE SAT HERE SEVERAL TIMES LISTENING TO
- 18 NELSON SAY AND PUSH THESE NEEDS ANALYSIS THAT THEY HAVE
- 19 FOUND THINGS LIKE THEY WERE UNDERGROUND LINES HERE THAT
- 20 NOBODY KNEW ABOUT, AND WE FOUND THAT IN A NEEDS ANALYSIS.
- 21 SO IF YOU CAN FIND UNDERGROUND LINES AND IF YOU CAN FIND
- 22 UNDERGROUND SINKHOLES AND IF YOU CAN FIND UNDERGROUND
- 23 CONCRETE BURIED THAT NO ONE KNEW ABOUT, IF YOU CAN FIND AN
- 24 UNDERGROUND FAULT LINE, WHY THE HELL CAN'T YOU FIND A
- 25 PROBLEM UNDER A WOODEN PLATFROM?

- 1 MR. PEREZ: LET ME CLARIFY. THERE ARE SEVERAL
- 2 COMPANIES THAT SPECIALIZE IN FINDING PIPES AND DUCTS, AND
- 3 THEY CAN TELL YOU THERE'S A LINE HERE, BUT THEY CANNOT TELL
- 4 YOU IF THERE'S A HOLE IN THAT PIPE OR IF IT'S BUSTED. BUT
- 5 YOU COULD ASK FOR THE INSPECTION OF THAT LINE AND SEE HOW
- 6 IT IS, BUT THERE COMES TO A POINT THAT YOU HAVE TO PUT A
- 7 LIMIT BECAUSE OTHERWISE THE NEEDS ANALYSIS WOULD HAVE TO

- MS. VANCE: IT IS HELPFUL. THANK YOU FOR DOING THAT.
- MR. PEREZ: WELL, THAT'S MY JOB.
- 13 AND THERE ARE THINGS THAT ARE IMPOSSIBLE TO
- 14 DETERMINE FOR THE BEST ARCHITECT IN A NEEDS ANALYSIS OR IN
- 15 A PROJECT OR DESIGN. FOR INSTANCE, THE NO. 6, THE EXISTING
- 16 DRAINAGE SYSTEM AT EXISTING SEISMIC SEPARATION WAS LEAKING.
- 17 WELL, YOU DON'T FIND THAT UNTIL YOU OPEN AND SEE. OKAY?

- 10 MR. PEREZ: YES. AT THE ROOF -- WE HAVE PROVIDED
- 11 PLENTY OF PICTURES OF BLAIR, AND THEY FOUND A CONCRETE SLAB
- 12 ON TOP, AND EVIDENTLY THEY DIDN'T THINK IT WAS OR IT WASN'T
- 13 THAT THICK.
- 14 MR. CATES: WAS THIS A HIDDEN CONCRETE SLAB?
- 15 MR. PEREZ: WELL, THE CONCRETE IS NOT VISIBLE IN THE

- 20 MR. CATES: JUST WONDERING.
- MR. PEREZ: NO, NO, NO. I TRY TO FIND A LOGIC TO WHAT
- 22 IS WRITTEN HERE. IT'S NOT THAT I CAN GIVE YOU A PRECISE
- 23 BECAUSE I'M NOT THE PROJECT MANAGER.
- 24 MS. VANCE: YOU'RE RIGHT. THEY MIGHT HAVE THOUGHT IT
- 25 WAS A SOFFIT. BECAUSE YOU'RE REALLY NOT GOING TO DRILL

- 1 THROUGH THE ROOF BECAUSE THEN YOU'LL CREATE A LEAK.
- 2 MR. CATES: WE UNDERSTAND THAT THE RENOVATION OF AN
- 3 OLD STRUCTURE ALWAYS INVOLVES UNFORESEEN ISSUES. IT'S JUST
- 4 IN THE NATURE OF THE WORK, AND A LOT OF THIS HAS TO BE
- 5 DONE. BUT TO ME SAYING THAT A SINK, A FAUCET, AND HOT
- 6 WATER IN A JANITOR'S CLOSET IS AN UNFORESEEN CONDITION IS
- 7 SOMEWHERE BETWEEN FUNNY AND INSULTING.
- 8 MR. PEREZ: MAYBE THE UNION ASKED FOR IT. THAT COULD
- 9 BE ONE ANSWER. YOU KNOW, AT SOME POINT IN TIME THE WATER
- 10 IS SO COLD, AND THE JANITOR'S CLAIM THAT THEY NEED WARM
- 11 WATER. THAT'S A SPECULATION.
- MR. HOCUTT: WE WILL MOVE ON, BUT I'LL HAVE TO ADD
- 13 THIS JUST FOR FUN, A LITTLE BIT OF LEVITY. IN DEFENSE OF
- 14 MIGUEL, WAKE FOREST UNIVERSITY IN NORTH CAROLINA WAS AT ONE
- 15 POINT MOVED FROM LAKE FOREST TO WINSTON, SALEM. THEY
- 16 REBUILT AN ENTIRE CAMPUS. IN DOING SO THEY BUILT
- 17 DORMITORIES. SOME OF THEM FOR WOMEN. WHEN THE FIRST
- 18 FEMALE CLASS MOVED IN, THEY FOUND THAT THERE WAS ONE THING
- 19 MISSING FROM THE WOMEN'S DORMITORIES. CLOSETS. IT
- HAPPENS.
- MR. CATES: WHAT? WE GUYS DON'T NEED CLOSETS TOO?
- 22 MR. HOCUTT: WE DON'T NEED THEM APPARENTLY. THEY HAD

- 25 MR. PEREZ: IN EUROPE THEY DON'T HAVE CLOSETS.

- 1 MR. CATES: YOU'RE RIGHT. AND THEIR ROOMS ARE A
- 2 FRACTION OF THE SIZE OF THE ROOMS IN THE UNITED STATES.
- 3 MR. HOCUTT: WE HAVE DIGRESSED.
- 4 1267 WAS THE APPROVAL OF THE -- ASKING THE BOARD
- 5 TO APPROVE THE ANNUAL REPORT BY THE COC. AS CLIFF HAS

- 1 MR. PEREZ: THESE TWO DOCUMENTS AND THE MEETING
- 2 MINUTES FOR EACH PROJECT ARE POSTED IN THE FACILITIES
- 3 WEBSITE.
- 4 MR. HOCUTT: WOULD IT NOT BE MORE APPROPRIATE TO POST
- 5 THE CONSTRUCTION STATUS REPORTS SINCE IT WAS OUR REQUEST TO
- 6 HAVE IT IN THE COC WEBSITE?
- 7 MR. PEREZ: IT'S PART OF THE MEETING MINUTES.
- 8 MS. VANCE: IT'S ATTACHED TO THESE MEETING MINUTES.
