## 2019-20 Chronic Absenteeism

Disaggregated by School Site

A "chronic absentee" is defined as "a pupil who is absent on 10 percent or more of the school days in the school year when the total number of days a pupil is absent is divided by the total number of days the pupil is enrolled and school was actually taught in the regular day schools of the district, exclusive of Saturdays and Sundays." ${ }^{1}$
The "eligible" sample below includes only K-12 students who were enrolled with the school/district for at least 31 days and did not attend zero days (i.e., at least a partial day attended).
In 2019-20 schools were physically closed due to a pandemic and schools were not required to record attendance after February 29, 2020. The 2019-20 school year therefore covers the period from the start of the school year through February 29, 2020.
