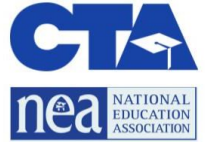

On behalf of the Pasadena Association of Career Technical Educators (PACTE), and pursuant to Article XXVII of the Collective Bargaining Agreement between the PACTE and PUSD, PACTE submits this request for reopener negotiations.

The PACTE proposes negotiations will include, but shall not be limited to, the following contractual articles:

Article XIV and applicable salary Appendices (Appendix A, Appendix A-1) – Salary and Salary Schedule Rules and Regulations: the PACTE has an interest in negotiating an equitable salary increase as well as other possible changes to the regular and supplemental salary schedules.

Article XV – Health and Welfare Benefits: the PACTE has an interest in negotiating equitable health and welfare benefits premiums and/or changes to the health/benefits plans offered.

In addition to the above, the PACTE would like to reopen Article III - Association Rights, Article VI - Hours, Article IX - Leaves, Article X - Class Size, and/or perhaps create/add one new Article to the contract.

The PACTE reserves the right to amend, modify, or add to this proposal during the course of negotiations.

The PACTE looks forward to productive negotiations when we begin negotiating on June 9, 2023. We all look forward to working with PUSD's negotiations team on this collaborative effort.
